World Health Organization (WHO) and The International EMF Project

The World Health Organization (WHO) is the United Nations (UN) group responsible for global public health. In order to address the growing health concerns about EMF exposure, in 1996, WHO launched The EMF Project, now known as an international project. Interestingly, the founder of the EMF Project was Michael Repacholi, who also founded the INCIRP.

There is collaboration between WHO and its sub-agencies, such as with the **EMF Project**, International Telecommunications Union (ITU), and the Agency for Research on Cancer (IARC).

INCIRP acts in an official advisory group for WHO. And WHO maintains close relations with the European Commission Directorate – General

for Health and Food Safety (DG SANTÉ), which oversees **SCHENIR/SCHEER**. (The International EMF Project Progress **Report** June 2015-2016).

By now, you know the drill.

WHO's OPINION:

Extensive research has been conducted into possible health effects of exposure to many parts of the frequency spectrum. All reviews conducted so far have indicated that exposures below the limits recommended in the ICNIRP (1998) EMF guidelines, covering the full frequency range from 0-300 GHz, do not produce any known adverse health effect. However, there are gaps in knowledge still needing to be filled before better health risk assessments can be made. (WHO EMF Research)

For more detail, see <u>Electromagnetic Fields and Public Health</u>: Radars and Human Health and please note the last sentence, "However, more research is needed to fill certain gaps in knowledge."

It seems like the majority of independent scientists may have filled in many of those gaps – already.

Another WHO publication is **Electromagnetic fields and public health: mobile phones**, which reported that To date, no adverse health effects have been established as being caused by mobile phone use.

That's their story; and they're sticking to it – still.

Please note the last paragraph on long-term exposure:

While an increased risk of brain tumors is not established, the increasing use of mobile phones and the **lack of data** for mobile phone use over time periods longer than 15 years warrant further research of mobile phone use and brain cancer risk. In particular, with the recent popularity of mobile phone use among **younger people**, and therefore a potentially longer lifetime of exposure, WHO has promoted further research on this group. Several studies investigating potential health effects in children and adolescents are underway.

The strong will oppress the weak. The rich will oppress the poor. The FIRST EXAMPLE of WHO being under fire discloses the shenanigans that go on in their scientific review process.


Shenanigans:

According to - "Will WHO kick its ICNIRP Habit" on Microwave News, WHO issued a public call in October 2019 for detailed literature reviews on ten types of RF-health impacts from cancer to fertility to electrohypersensitivity.

But before thinking this is a sign that WHO is interested in opinions beyond those of its core group, look how it handled the public call, as described in the article.

Article notes:

In 2012, the WHO Radiation Program started working on a revision to its 1993 Environmental Health Criteria (EHC) monograph, with a target completion date of 2016. Eleven chapters of a draft report were released in 2014; however missing were at least three chapters. Public comments to that draft were never released. Not surprising - the second draft got stalled.

Many question if WHO is just only going through the motions, and plans to stick with ICNIRP's position that there are no RF effects other than those caused by heating – most of us can make a wager on the results.

WHO set a very tight schedule. Emilie van Deventer, the team leader of the WHO radiation program, sent a notice, dated September 2019, to her mailing list, but according to Microwave News, some didn't receive it until October 8. The deadline for the responses to the public call was November 4, 2019. This is a narrow window of time, given that putting together review teams is no easy task.

If scientists weren't on her mailing list, their chances to answer the call were thwarted. Dr. Joel Moskowitz, who is critical of INCIRP, and Dr. Dariusz Leszczynski, who was a member of the IARC RF-cancer assessment in 2011, were not on her list.

The article brings up additional aspects of the rush timeline and questions about the selection process, budget, and disclosure of "winners".

The timeline is also suspicious, because WHO EMF managers knew years ago that reviews would be required as part of new writing procedures; and. Van Deventer laid out what had to be done at an EMF Project advisory committee meeting in June 2017.

Why did she wait until last autumn to issue the call with that tight schedule, given she regularly briefed the International Telecommunications Union (ITU), informing them WHO would review the 2014 draft? In May 2019, she told them that she would commission eight systematic reviews (later expanding to ten). Why were telecom managers better briefed on the pending reviews than those in the health sciences who would be doing them?

A few days earlier at the same ITU meeting, the Mobile and Wireless Forum (MWF), a trade association formerly known as the Mobile Manufacturers Forum, was invited to give a presentation on "Preparing for 5G: Research Relating to RF Exposure."

E-mail traffic, shared with Microwave News, shows that van Deventer's briefings were well circulated among ITU's corporate members who follow the health question.

The lack of advance notice and the fast deadline have led some to question whether the WHO engineered the schedule to help ICNIRP stay in control... ICNIRP members would be well prepared to respond to the calls. They have recently finished their own literature reviews to update ICNIRP's exposure guidelines, issued in 1998. (End of article notes)

The ITU is a public-private partnership with many government and corporate members. ITU coordinates the shared global use of the radio spectrum. They were included in a question posed by Take Back Your Power's article **The Dominoes Are Starting To Fall**.

Oleg Grigoriev, the chairman of the Russian national non-ionizing radiation committee, complained that the core group that drafted the 2014 **ICNIRP** report was –

[IT WAS] not balanced and [did] not represent the point of view of [a] majority [of the] scientific community studying [the] effects of RF." He and others were disappointed that the WHO had failed to go beyond the heat-only dogma embraced by ICNIRP.

SIDE NOTE – Russian Right-To-Know:

Oleg Grigoriev was instrumental in the call for a Russian Right-To-Know consumer warning. Following a release of a published paper co-written by Oleg Grigoriev, in October 2019, the Russian National Committee on Non-Ionizing Radiation Protection <u>called</u> for the release of **new EMF hazard warning signs** for wireless users of mobile phones and other EMF sources. By the way, Oleg Grigoriev has a <u>twitter</u> account in English.

<u>Luke 12:1</u> In the mean time, when there were gathered together an innumerable multitude of people, insomuch that they trode one upon another, he began to say unto his disciples first of all, **Beware ye of the leaven of the politicians, which is hypocrisy.**

The **SECOND EXAMPLE** of WHO being under fire reveals a more sinister plot than just shenanigans.

In the report, "World Health Organization: Setting the standard for a wireless world of harm," Olga Sheenan accuses WHO of industry infiltration, intentional ignorance, denial of the science, and disregard for humanity, as described in the report.

Industry Infiltration:

Sheenan cites one example of industry infiltration as Emile van Deventer, the project head, because she has no medical or health qualifications, but was an electric engineer who carried out industry-funded research.

Intentional ignorance:

Important UN documents are translated into the official UN languages of French, Spanish, Chinese and Russian, among others.



Due to restricted language competence of available experts and restricted options for translations, none of the identified Russian papers and only epidemiological Chinese papers have been included.



Olga Sheenan also wrote that it is widely known that Russian scientists are way ahead of the west, in terms of their EMF research and expertise. Studies published in recent years reveal that over 40 Russian-language papers have been missed (the abstracts, in English, can be found on most scientific citation databases). This means not only that WHO will not assess all of the literature, but also that the literature from China and Russia, where RF emission standards are justifiably more stringent, is being intentionally omitted.

Important primary research studies and papers describing the rationale and evidence for the Russian standards being 100 times more stringent (safer) than those of ICNIRP, Canada, the USA and most European countries, have been made to un-happen.

Denial of the science:

The review will consider only "experimental studies with laboratory animals and observational studies on domestic animals". Dismissed would be the well-designed and blinded study conducted on the European robin – clearly demonstrating non-thermal effects of ambient radiofrequency radiation. Also excluded would be the many studies on insects and plants, which show non-thermal effects at below international standards.

Sheenan also brought up that the review process failed to involve specialists, also writing that WHO made it physically impossible for scientists to comment on the material that was withheld – missing.

My problem is the unfinished documents and the missing, unwritten chapters. This is not how consultation should be done. Documents should be reading, including conclusion and recommendations. As it is now, the WHO EMF Project is pretending to conduct consultations...

Disregard for humanity:


Sheenan describes more shenanigans -

Flydal also explained that the guidelines take in only human results; and because humans live a long time compared to bees, the DNA damage shows up much slower. NGOs also get away with excluding studies on environmental damage like dying trees.



Gibraltar is also playing a responsibility disclaimer game - pay attention.

By choosing humans, they ensure the damage will show up fairly slowly.

This would seem to be what they are banking on. There's plenty of money to be made in the mean time. By the time they are forced to recognize the dangers, the **DEATH STAR** would have already been built – so to speak.

Do you understand that? Read the **EKLIPSE REPORT**.



The Environmental Risk Assessment:

Where is the environmental risk assessment from the **Ministry of the Environment** when it comes to EMF radiation and its effects on the gardens, apes, bats, migrating birds and bees?

Consider a report done in 2012 in India, entitled, <u>Impacts of radio-frequency electromagnetic field (RF-EMF) from cell phone towers and wireless devices on biosystem and ecosystem – a review</u>.

The Department of Telecommunication in India set new norms for cell phone towers with effect from September 1, 2012. Exposure standards for RF-EMF radiation has been reduced to one-tenth of the existing level and SAR from 2 to 1.6W/kg. This came after the ministry of environment and forest set up an Inter-ministerial Committee to study the effects of RF-EMF radiations on wildlife (Figure 2) and concluded that out of the 919 research papers



collected on birds, bees, plants, other animals, and humans, 593 showed impacts, 180 showed no impacts, and 196 were inconclusive studies.

Again, claiming no evidence exists is a matter of opinion – and the Gibraltar Ministry of Health and the Environment is failing its due diligence.

As a reminder, the India report referenced the general public power density levels in W/m² applied to different countries, shown in its table to the right.

Well, certainly not all of them bank on what the ICNIRP and IFFF tell them.

Are the countries with stricter limits just full of stupid luddites and falsely-alarmed government officials? That's a stupid question, because clearly they seem to take EMF radiation concerns more seriously.

In truth, many global catastrophic events are "industry-made" – this includes all pollution industry unleashed on the world since the Industrial Revolution. Still today, they are allowed to pollute the ground, water and air – and EMF radiation is a toxic pollutant.

India's report included references to studies, with the following excerpts –



1 – Bees have clusters of magnetite in the abdominal areas. Colony collapse disorder (CCD) was observed in beehives exposed to 900MHz for 10 minutes, with sudden disappearance of a hive's inhabitants, leaving only queen, eggs, and a few immature workers behind. With navigational skills affected, worker bees stopped coming to the hives after 10 days and egg production in queen bees dropped drastically to 100 eggs/day compared to 350 eggs. (Sharma and Kumar, 2010)



2 – Frogs: In a two-month study in Spain in common frog tadpoles on the effects of mobile phone mast located at a distance of 140 m noted low coordination of movements, an asynchronous growth, resulting in both big and small tadpoles, and a high mortality (90%) in exposed group. For the unexposed group in Faraday cage, the coordination of movements was normal, the development was synchronous, and a mortality of 4.2% was obtained (Balmori, 2009).





3 - A study by the Centre for Environment and Vocational Studies of Punjab University noted that embryos of 50 eggs of house sparrows were damaged after being exposed to mobile tower radiation for 5-30 minutes (MOEF, 2010). Observed changes included reproductive and coordination problems and aggressiveness. Tower-emitted microwave radiation affected bird breeding, nesting, and roosting in Valladolid, Spain (US Fish & Wildlife Service, 2009). House sparrows, white storks, rock doves, magpies, collared doves exhibited nest and site abandonment, plumage deterioration (lack of shine, beardless rachis, etc.), locomotion problems, and even death among some birds. No symptoms were observed prior to construction of the cell phone towers.

4 - White storks were heavily impacted by the tower radiation during the 2002-2004 nesting season in **Spain**. Evidence of a connection between sparrow decline in UK and the introduction of phone mast GSM was established (Balmori, 2009). In a study in Spain, the effects of mobile phone masts have been noted in house sparrow (Passer domesticus), white stork (Ciconia ciconia), reporting problems with

reproduction, circulatory, and central nervous system, general health and well-being (micro- wave syndrome) (Balmori, 2009). Deformities and deaths were noted in the domestic chicken embryos subjected to low-level, nonthermal radiation from the standard 915MHz cell phone frequency under laboratory conditions (USFWS, 2009).



5 - Bats use electromagnetic sensors in different frequencies. Since 1998, a study on a free-tailed bat colony, having Tadarida teniotis and Pipistrellus pipistrellus has been carried out in Spain and a decrease in the number of bats were noted with several phone masts 8om from the colony. A dead specimen of Myotis myotis was found near a small antenna in the city centre (Balmori, 2009).

How will the bats in Gibraltar fair with even more EMF radiation? Perhaps the ones who study them would be interested or concerned, because the number of bats have plummeted over the years, according to Gibraltar National Museum's GIB BATS.

6 – The most affected of the species are bees, birds, and bats and without these pollinators visiting flowers, 33% of fruits and vegetables would not exist, and as the number of pollinators decline, the agricultural crops will fall short and the price of groceries will go up (Kevan and Phillips, 2001).


Also concerning bats: Why would researchers study this - Bats Avoid Radar Installations: Could EMF Deter Bats from Colliding with Wind Turbines?

Just a reminder – killing off the pollinating bees is considered a catastrophic event, as so is annihilating a species. Einstein said that if the bees disappear, within three years so will mankind.

Value nature not stuff:

According to the National Geographic article, One million species at risk of extinction, UN report warns, economic growth is going to have to take a back seat.

In order to safeguard a healthy planet, society needs to shift from a sole focus on chasing economic growth, the summary report concludes. That won't be easy, the report acknowledges. But it could get easier if countries begin to base their economies on an understanding that nature is the foundation for development. Shifting to nature-based planning can help provide a better quality of life with far less impact.



The Barbary macaque population in Gibraltar is the only wild monkey population on the European continent. They occupy the Upper Rock area of the Gibraltar Nature Reserve, though they make occasional forays into the town. Have they been unknowingly experimental monkeys in mankind's world of WIFI?

The bonds that hold nature together may be at risk of unraveling from deforestation, overfishing, development, and **other human activities**, a landmark United Nations report warns. Thanks to human pressures, one million species may be pushed to extinction in the next few years, with serious consequences for human beings as well as the rest of life on Earth.

The UN's Global Assessment Report on Biodiversity and Ecosystem Services was published in May 2019, which is **summarized** on Wikipedia.

The report states that in the past half-century, the Earth's biodiversity has suffered a catastrophic decline. It examined the rate of decline in biodiversity and found that the adverse effects of human activities on the world's species is "unprecedented in human history" – one million species, including 40 percent of amphibians, almost a third of reef-building corals, more than a third of marine mammals, and 10 percent of all insects are threatened with extinction.



The Report warned that society should not fixate on economic growth, and that countries should "base their economies on an understanding that nature is the foundation for development."

How is this warning going to fit in with the rat-race of winning in the 5G arena for "economic growth"? Most governments are likely to let it slide, because they'll still value money first. They are so focused on it that they can't see how selfish they are – or even how blind they've become.

The selfish case for saving bees: it's how to save ourselves – Guardian article features on the UN report and some of the reasons bees are becoming extinct.

This month a landmark UN global assessment report warned that a million wildlife species were facing extinction, and at an unprecedented rate. Thousands of bee species will be among them. In Europe, 37% of them have experienced a recent decline in populations, and 9% face extinction; almost a quarter of those in North America are at increasing risk of becoming extinct.

Human society under urgent threat from loss of Earth's natural life – Guardian article added:

The biomass of wild mammals has fallen by 82%, natural ecosystems have lost about half their area and a million species are at risk of extinction – all largely as a result of human actions, said the study, compiled over three years by more than 450 scientists and diplomats.

In 2017, the Guardian alerted readers about the declining insect numbers – Warning of 'ecological Armageddon' after dramatic plunge in insect numbers:

The abundance of flying insects has plunged by three-quarters over the past 25 years, according to a new study that has shocked scientists.

Shocked is probably too dramatic of a word – they've known for a long time that instead of getting better, things are getting worse. Many are just paid to hide it, skirt the issue, or deceive. As long as they can keep it in the category of we don't know why yet, real solutions are unlikely to occur.

And concerning the issue of birds, bees and the like, the UN report conveniently ignores the big elephant in the room. For example, besides real estate development and pesticides wreaking havoc on the populations, they ignore possible technological saturation involved in **environmental degradation**, which is defined as **any** change or disturbance to the environment perceived to be deleterious or undesirable. When it comes to Bee Colony Collapse (BCC), nothing should be overlooked.

For example, take the often cited U.S. Fish and Wildlife Report – "Briefing Paper on the Need for Research into the Cumulative Impacts of Communication Towers on Migratory Birds and Other Wildlife in the United States Division of Migratory Bird Management (DMBM)"

Radiation has also been implicated in effects on domestic honeybees, pollinators whose numbers have recently been declining due to "colony collapse disorder" (CCD) by 60% at U.S. West Coast apiaries and 70% along the East Coast (Cane and Tepedino 2001). CCD is being documented in Greece, Italy, Germany, Portugal, Spain, and Switzerland. One theory regarding bee declines proposes that radiation from mobile phone antennas is interfering with bee navigational systems. Studies performed in Europe have documented navigational disorientation, lower honey production, and decreased bee survivorship (Harst et al. 2006, Kimmel et al. 2006, Bowling 2007). This research needs further replication and scientific review, including in North America. Because pollinators, including birds, bees, and bats, play a fundamental role in food security (33% of our fruits and vegetables would not exist without pollinators visiting flowers [Kevan and Phillips 2001]), as pollinator numbers decline, the price of groceries goes up.

In May 2009, The U.S. Fish and Wildlife Service urged Congress to investigate the potential relationship between wireless devices and bee colony collapse.

Despite the UN-WHO refusing to look at the possibility that EMF radiation as a possible cause, there are more studies connecting the dots, similar to the U.S. Fish and Wildlife report.



The EKLIPSE project (Establishing a European Knowledge and Learning Mechanism to Improve the Policy-Science-Society Interface on Biodiversity and Ecosystem Services) is another example of assessing the situation in terms of how EMF radiation might be involved. The increase of EMR and its potential effects on wildlife has already been identified by an international experts group led by Bill Sutherland as 1 of the 15 emerging issues that could affect global biodiversity but that are not yet well recognised by the scientific community. (A report of the EKLIPSE project).

A key policy recommendation refers to the urgent need to allocate more funding to research on the topic. Participants also emphasized the importance of

bringing together different stakeholders (not only scientists, but also policymakers, businesses, citizens, decision makers, etc.) and to set up advisory groups. Finally, some participants recommended to apply the **precautionary principle**, to define and set safe limits to EMR exposure, and to **avoid placing EMR sources in nature reserves/wildlife areas**.

Buglife initiated the EKLIPSE report and its CEO Matt Shardlow warned in the article <u>Our cellphone addiction is</u> <u>turning wireless tech into a visual weapon that's destroying wildlife</u> –

There is a credible risk that 5G could impact significantly on wildlife.

He called out to telecommunications firms to research the impact of their wireless technology on wildlife and to make their findings public. More of his interview can be read in The Telegraph article – <u>Electromagnetic radiation</u> from power lines and phone masts poses 'credible' threat to wildlife, report finds.

Dr. Joel Moskowitz also <u>featured</u> the EKLIPSE report on his website Electromagnetic Radiation Safety. He and others have <u>reached</u> out to the United Nations Environment Programme. In a letter in July 2019, they urged the UNEP to undertake an unbiased, comprehensive review of the scientific literature on EMF effects on the natural environment and make recommendations that could be applied as an integral part of developing international and national health-based and <u>environmentally-protective</u> EMF-exposure standards.

Still yet another resource is the EHTrust – Bees, Birds and Wildlife.

The article <u>Wireless Devices & Wildlife: The effects of EMR from wireless devices on wildlife</u> briefly sums up other studies.

Excerpts include -

Bees and other insects, just as birds, use the Earth's magnetic field and high frequency electromagnetic energy such as light. They accomplish orientation and navigation by means of free radicals as well as a simultaneously reacting magnetite conglomerate. Technically produced electromagnetic oscillations in the MHz range and magnetic impulses in the low frequency range persistently disturb the natural orientation and navigation mechanisms created by evolution.

Recent studies from Europe raise troubling concerns about the effects of radiation from **cellular communication antennas**, **especially on resident**, **breeding migratory birds**. These apparent effects include feather deformities, weight loss, weakness, reduced survivorship and death, especially to those birds and their offspring nesting adjacent to cellular antennas. Where Before-After, Control-Impact (BACI) studies

were performed during some of the European research, no effects to resident birds were detected prior to construction and operation of cellular communication antennas. – Dr. Manville

Trees are now dying mysteriously from a variety of diseases in urban areas all over Europe. They also show abnormal photoperiodic responses. All of these can be explained as a result of exposure to weak RF fields

from mobile phones, their base stations, Wi-Fi and similar sources of weak non-ionizing radiation. – British biologist Dr. Andrew Goldsworthy

Robins can navigate in the Earth's magnetic field if they receive light from wavelengths absorbed by cryptochrome. However, **exposure** to man-made frequencies between 0.1 and 10MHz at field strengths as little as 0.085 mT (about 500 times weaker than the Earth's magnetic field) **made the birds completely unable to respond to the Earth's field**.

The sheer number of wireless devices gives birds continuously conflicting navigational data – as if they're constantly bombarded by flashing disco lights. We should not be surprised that birds would leave such areas. Likewise, scientists who put DECT cordless phone base stations next to their beehives found that their bees behaved abnormally and were less likely to return to the hive. (Beekeepers are thereby well advised not to carry their mobile phones when visiting their hives.)

Radio-frequency radiation interferes with the biological clock:
