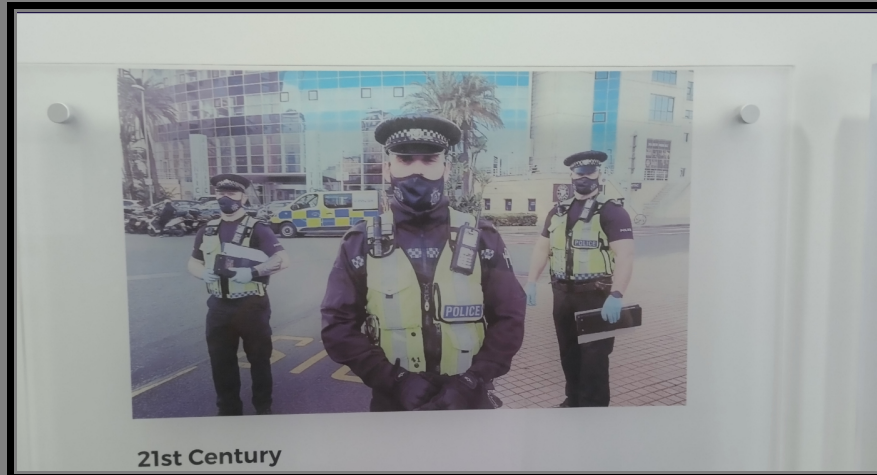

INTRODUCTION

One hundred and five days have elapsed since our initial crime report submission to Richard Ullger, the Commissioner of the Royal Gibraltar Police. That was on 24th July 2024. During the intervening period, a plethora of new and highly relevant intelligence submissions have been shared amongst various members of the Gibraltar Messenger's team. Most intelligence examined in this context, has been reviewed, assessed, and filtered for relevance in order to supplement the very serious allegations previously made against Pfizer and Fabian Picardo. Operating within the spirit of Project Servator, the Gibraltar Messenger was keen for relevant information and actionable intelligence to be brought to the attention of The Royal Gibraltar Police, at Senior Command Team level. This report fulfils that objective.

PURPOSE OF THE ADDENDUM REPORT

- to update the Commissioner of The Royal Gibraltar Police on the quantity and quality of new intelligence received about Covid related issues that have come to light from across the globe on Pfizer's / Big Pharma medical tyranny;
- to share with the Commissioner of The Royal Gibraltar Police, the nature of our conceptual model of the imminent strategic threat associated with the latest WHO announcement about MPOX, which has been declared a Public Health Emergency of International Concern PHEIC. This is especially relevant given that the subject has on more than one occasion, attracted attention and public comment from Dr. Helen Carter, the Director of Public Health.

BACKGROUND

This report should be read in conjunction with my previous crime submission in late July 24. That submission was delivered in the form of a four part report, calling upon an array of Covid related intelligence submissions, previously gathered and assessed by The Gibraltar Messenger Team. This report was not published on The Gibraltar Messenger website owing to its sensitive nature. The four separate parts of the crime report's submission had headings as follows:

- “Picardo and His Local Accomplices in Crime”;
- “How Do You Solve a Problem Like Pfizer?”
- “The Deafening Sound of Silence of Excess Deaths”
- “So How Do You Solve a Problem Like Picardo?”

A PAUSE FOR THOUGHT MOMENT – INTERNAL TYRANNY

For the scene for the main analysis within this addendum, there first ought to be a pause for thought moment - a focus on the subject of tyranny and strategic threat. It's a topic which I am not ashamed to say got me fired from the UK police service. 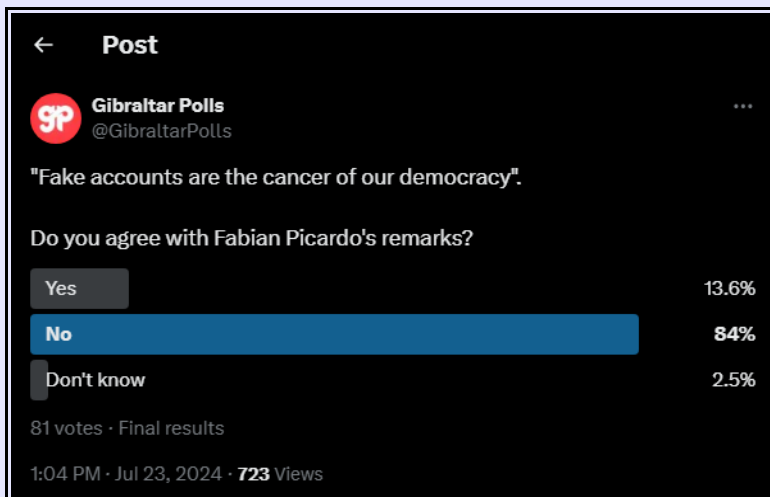
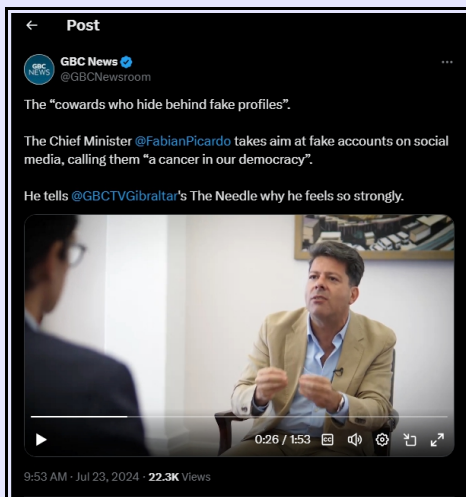

EXECUTIVE SUMMARY

Within the original crime report submitted on 24th July 2024, there were 83 insightful links to support the call for action to be taken against the tyrant Fabian Picardo, with respect to the draconian measures he introduced in response to all things Covid. The eleven pages of tabulated data in this addendum, covering the period from the crime report's submission to present, contain chronologically, 151 new Covid related informative articles / postings, all of which are deemed essential in obtaining a RICH PICTURE about the tyranny within our midst. The data is offered up to the RGP, as actionable intelligence. The time for demonstrating yet more wilful blindness to the crisis in our midst, is over. Ever since 7th July 2021, The Gibraltar Messenger, and other members of His team, including me, as a former intelligence analyst, have been formally trying to helpfully alert the Royal Gibraltar Police to the rapidly emerging global catastrophic crisis which is about to fall upon us all.

Of the 151 articles on show, all are worthy of a read for gaining extra-special insight, but some are classed here as perhaps more essential reading than others. The Royal Gibraltar Police (RGP) oath of office is a solemn commitment taken by new recruits when they are officially sworn in as police constables. Here is the specific wording of their oath:

*"I do solemnly and sincerely declare and affirm that I will well and truly serve the King in the office of constable, with fairness, integrity, diligence and impartiality, **upholding fundamental human rights** and according equal respect to all people; and that I will, to the best of my power, cause the peace to be kept and preserved and prevent all offences against people and property; and that while I continue to hold the said office I will to the best of my skill and knowledge discharge all the duties thereof faithfully according to law."*

This oath emphasizes the core principles of fairness, integrity, and the protection of human rights, reflecting the RGP's stated commitment to serving the community with respect and diligence.

Presumably this means protecting life, and not causing further death.

But again, I say, mistakes were not made, and we do not know if Gibraltar's Cancer Rates are soaring. The last published study was done in 2010. Yet, Fabian says he will keep nothing from us. Neither Fabian Picardo, nor Dr. Helen Carter, will want police officers to know the real RICH PICTURE. They will clearly not want to tell the public themselves about what is happening, contrary to the Chief Minister's hollow rhetoric that nothing will be kept from us with respect to Covid, as previously well-documented in the crime report. Their positions are indefensible. Police officers, solicitors, health professionals and the public in general, all need to be shown this data too. Fabian Picardo's idea of truth is warped beyond repair. The police, if they are not yet prepared to arrest Fabian Picardo over his part in the vaccine roll-out, could nevertheless easily do their bit here, by showing in full the crime report, and this addendum to both Fabian Picardo, and Helen Carter in the first instance. Both of them could conceivably be invited into New Mole House for questioning. This could conceivably be just like the Royal Gibraltar Police expertly did to me and Samuel Lloyd over the artistic props of Gaza rubble, as left on the doorsteps of the GSD office, after a well meaning little stunt incorrectly and ludicrously got described in the press as vandalism, when it was nothing of the sort. Since I had nothing to hide over that, it was a pleasure to voluntarily assist the police with their enquiries. WHO's PHEIC (fake) Monkeypox Unleashed

INFERENCE

In the aftermath of the Covid-19 era, Monkeypox is on the verge of being engineered as the next global PLANDemic. MPOX, as it has been recently relabelled, is to be used as the much needed cover-story to disguise the global DEMOCIDE that has long since been set in motion, initiated most obviously, but not exclusively, through the Covid-19 kill-shots and subsequent booster roll-out programmes, as unleashed upon the largely unsuspecting masses from 2021 onwards. The WHO is presently for a second time, declaring Monkeypox as a global Public Health Emergency of International Concern (PHEIC), for the half-hidden purposes of population reduction and control by stealth. The criminal puppets of The World Health Organisation, funded by Bill Gates and significantly, Jewish Billionaire, Dustin Moskowitz, are each respectively upfront and behind the scenes, in promoting the MPOX / Monkeypox narrative. As with Gibraltar's previous response to the globalist's planned Covid-19 outbreak, ominously Dr. Helen Carter, the Director of Public Health, with no doubt the Chief Minister Picardo's blessing, alongside the GBC's full support, have collectively wasted no time at all being once again in full lockstep with the globalists' wider evil depopulation plan. PREMISES

1. Any understanding of the nature of this strategic threat, is predicated on some familiarisation with the insightful work of **Dr. David Martin**, who explains that the architects of Covid-19 have been planning to readjust the global financial system for a long time. With respect to MPOX, Dr. Martin says billionaire Dustin Moscovitz, the co-founder of Facebook, hides in the shadows behind his foil, Mark Zuckerberg. Moscovitz was the one who not only wrote the check to fund Event 201, a meeting that took place just weeks before the Covid-19 pandemic was announced, that created new policies on how to make people compliant during a pandemic. Moscovitz was the one who also predicted a global outbreak of Monkeypox in May 2021 following a desktop exercise conducted by the Nuclear Threat Initiative (NTI) in March 2021. Moskovitz also has an investment in CRISPR technology that Dr. David Martin asserts will be unveiled as the future of humanity after the original human genome is destroyed. Dr. David Martin is not alone. **Prof. Shmuel Shapira MD MPH (Col.)**, who served as Director of the Israel Institute for Biological Research between 2013 and 2021, suggested that the Monkeypox outbreak was connected to mRNA vaccines. He has been subjected to severe censorship for attempts to expose the truth about the mRNA vaccines and their links to MPOX. 3. The Commissioner of The Royal Gibraltar Police, may recall my previous intelligence submissions associated with the “Died Suddenly” film, as produced by Stew Peters, in association with my scathing criticism of one of Gibraltar's Desk Top Terror Drill Exercises. Given that the Commissioner has read my crime report, by now he ought to be familiar with the work of courageous **Bio-Analyst Karen Kingston**. Regarding the subject of the threat manifesting itself as Monkeypox, Karen Kingston appeared on the Stew Peters show and gave this most insightful interview, which again is highly recommended for edification, as it expertly covers one of the real strategic threats confronting the police service at times such as this. 4. The World Health Organization (WHO) first declared MPOX (formerly known as Monkeypox) a Public Health Emergency of International Concern (PHEIC) on July 23, 2022. It was stated that this first declaration was made in response to the global outbreak that began spreading rapidly in multiple countries outside of Africa. Then again, on 14th August 2024, Tedros Adhanon Ghebreyesus, the Director General of The World Health Organisation, declared another MPOX PHEIC/fake. This time he stated that this decision was made due to the rapid spread of the virus in the Democratic Republic of the Congo (DRC) and other countries in Africa. The WHO emphasized the need for a coordinated international response to control the outbreak and prevent further spread.
5. In August 2024, in response to the WHO declaring a Monkeypox a PHEIC, **Australian Senator Malcolm Roberts** boldly and very publicly stated that the time of blind trust in WHO's narrative is over; it's now the age of “prove it”. The Australian Senator, pointed out that the WHO is influenced by big pharmaceutical companies. It lacks transparency in its dealings, and there is conflict of interest with vaccine sales. 6. Gibraltar's position on the WHO pandemic treaty would be typically aligned with the United Kingdom's position. However, neither Fabian Picardo, nor Dr. Helen Carter, nor the opposition GSD party appear to have put out any statements regarding the dangerous proposed treaty, despite the fact that some UK politicians have been outspoken on the subject in direct opposition to the power-grab of the unelected WHO regarding its three year pursuit of a global dominance. These include:
 - Former Tory MP, [Andrew Bridgen](#), who has spoken so insightfully about the Threat of The WHO Pandemic Treaty, as covered extensively on The Gibraltar Messenger website and spoke extensively at the EU in July 2023 about the Global Pandemic Treaty. - Nigel Farage, who launched a [Campaign against the WHO Pandemic Treaty](#) has raised the alarm repeatedly by saying that lockdowns and compulsory vaccines must NOT be forced on Britain by foreign officials. He has repeatedly urged MPs to reject 'terrifying' [WHO treaty](#) on future pandemics.
 - David Davis, who famously said to the then Prime Minister Boris Johnson [“In The Name of God, Go!”](#), has expressed opposition to the UK signing the WHO'S proposed pandemic treaty.
7. With reference to the new Prime Minister Kier Starmer, whom Nigel Farage has described as full-fledged globalist, the treasonous nature of UK's declared allegiances to Klaus Schwab's World Economic Forum, are all too hidden in plain sight. When Starmer was asked in an interview with the BBC's Emillie Maitlis to choose between WESTMINSTER or [DAVOS](#), Starmer without any hesitation chose [DAVOS](#).
8. This prompted some satirical comparisons with DAVROS, the fictitious creator of the DALEKS. Starmer candidly described Westminster as follows:

“It's closed and we are not having meaning... once you get out of Westminster, whether it's Davos or anywhere else, you actually engage with people that you can see working with in the future. Westminster is just a tribal, shouting place,”

Davos, a picturesque town in Switzerland, is closely linked to the World Economic Forum (WEF) because it hosts the WEF's annual meeting every January. Over 50 heads of state and government attended Davos in 2024. Be aware that the [OECD](#), which Picardo lauded back in [2019](#), is linked to Klaus Schwab's World Economic Forum.

9. Breaking news today, is an article on the [Truthseeker](#) website which states that World Economic Forum finally tells the truth about Covid: It was a 'test' of our obedience to rapidly forming new world order.



Our world is transforming – big community trends for sustainable cities

There have been significant developments in last five to seven years on social, environment and technology fronts that could help realise “My Carbon” initiatives for shaping the future towards smart and sustainable cities.

Specifically, to mention three developments in this context:

1. COVID-19 was the test of social responsibility – A huge number of unimaginable restrictions for public health were adopted by billions of citizens across the world. There were numerous examples globally of maintaining social distancing, wearing masks, mass vaccinations and acceptance of contact-tracing applications for public health, which demonstrated the core of individual social responsibility.

10. Contrary to the Chief Minister's historical declarations about keeping nothing from us, as highlighted on page 3 of my initial crime report, the true nature of this Monkeypox threat, as opposed to the false gaslighting narrative of the deep-state WHO, is first being brought to the Gibraltarians:

not by the Director of Public Health, Dr. Helen Carter, nor indeed not by any other member of the GHA;

not by neither the GBC, nor the Gibraltar Chronicle, nor the Olive Press;

not even by Picardo's own newspaper named the New People ;

and not by any of the many legal practitioners on The Rock;

but rather by the Gibraltar Messenger Himself, via an article, as posted as recently as 22nd August 2024, on **The Gibraltar Messenger's website**. The GM article is highly recommended to read in the wider context of this strategic threat assessment report.

11. Nowhere is The WHO's fixation with the mass injection of the world's population, more starkly exposed than in WHO's actions in the last week or so. These were about providing 640,000 polio injections for the children in Gaza. If anyone still needs proof that the QATAR-based Hamas leadership is in league with Israel – here it is. 13. In July 2024, Picardo appeared on the GBCTV programme aptly named THE NEEDLE!. The Chief Minister talked with a forked tongue in terms of the biggest existential threat being fake profiles, and spoke of that being cancerous. When Jonathan Scott asked Picardo about how to combat the threat, the Chief Minister, without any hesitation whatsoever, asserted that the threat should be **called-out**. 14. The Florence Nightingale Field Hospital in Gibraltar was established as a temporary measure during the COVID-19 pandemic. It was set up at the Europa Point Sports Complex and was ready for use by April 2020. The cost of setting up the hospital was approximately £2.5 million. It has been said that this temporary hospital was part of the efforts to manage the healthcare needs during the crisis. It was never needed. The main hospital facilities in Gibraltar were able to manage the patient load, so the field hospital served as a backup, kept on standby and was decommissioned in June 2021. To some deluded ones who believe this, the segment in the London 2012 Olympics opening ceremony supposedly celebrating healthcare workers, can be seen as a precursor to the widespread appreciation shown during the COVID-19 pandemic, such as the "Clap for Carers" initiative. During the pandemic, people around the world mindlessly banged pots and pans, clapped, and cheered to show their gratitude for healthcare workers on the front lines, while not being told that many wards around the world were empty. To others, the depiction of nurses and a mannequin of Boris Johnson in a hospital bed during the London 2012 Olympics seemed rather like predictive programming in action for the planned COVID-19 pandemic. Indeed, with reference to the WHO, Andrew Bridgen in his speech mentioned Florence Nightingale like so.

"So the World Health Organization is an unelected diplomatically immune, tax exempt group, that bears no resemblance to the Good Faith Florence Nightingale Union of Nations set of over 75 years ago. Public health and the decisions surrounding it now exist as a monopoly of the WHO headed-up by bureaucrats in Geneva whose leadership has been embroiled in scandal after scandal and the majority of the influence on the WHO now is by external entities, and indeed as has been mentioned, one of the richest men in the world has a massive influence over the WHO."

15. The "75-year rule" refers to the timeline proposed by the U.S. Food and Drug Administration (FDA) to release all the documents related to the approval of the Pfizer-BioNTech COVID-19 vaccine. The FDA suggested that it would take 75 years to fully release these documents, which amounted to around 450,000 pages. The FDA's reasoning for this lengthy timeline was due to the sheer volume of documents and the need to review and redact sensitive information, such as personal data and proprietary information, before making them public. However, this proposal was met with significant public and legal pushback. A federal judge later ruled that the FDA must expedite the release of these documents, requiring them to produce 55,000 pages per month, which drastically shortened the timeline to about eight months. It was claimed that the intention behind the original 75-year timeline was likely to ensure thorough review and redaction of sensitive information, but it was perceived by many as an attempt to withhold information from the public for an excessively long period. Some like Andrew Bridgen, could be forgiven for intentionally or otherwise linking two starkly contrasting events with 75 years. Suffice to say, nine pages from the released documents provide the proof as to why the FDA and Pfizer-BioNTech COVID-19 vaccine, so desperately wanted things kept secret.

16. Once upon a time, Richard Ullger, The Commissioner of The Royal Gibraltar Police candidly declared that he found the New Zealand's former Prime Minister, an inspirational leader and even posted it on X. Jacinda was a prominent voice on the Klaus Schwab's WEF. Perhaps his/her popularity peaked following speeches in the aftermath of the Christchurch mosque shooting incidents and the volcanic eruption on White Island. And why did we have to have a protracted distraction in the Ukraine? What did we have to have caravans of vehicles leaving biological facilities in the Ukraine? What do we have to move all kinds of things allegedly into the cover of night or out of labs into the cover of canopy trucks and so forth? Why did we need to do that? And why is it that the regions that were affected by a number of the pathogens associated with Monkeypox also happened to be installations that also had the African swine flu? And is it possible that maybe we're going to have an announcement that we have a Monkeypox outbreak, but in fact what we're going to do is we're going to once again build a series of toxins? Now remember we've got a tiny little problem because since you could get COVID without ever having SARS-CoV-2 remember this is the disease that mysteriously can be caused by a thing that doesn't cause the thing because we were told in every declaration that closed down every state and every country that SARS-CoV causes COVID except for the tiny fact that most people who tested positive for SARS-CoV-2 never got COVID and most people who had COVID never tested positive for SARS-CoV-2 so the causative relationship is slightly mysterious. Add to that the fact that the only protracted death increases that we saw were after we started injecting people with spike proteins and all sorts of other things that were in the cocktail that we were injecting. And now all of a sudden we're looking for the world's basket of pathogens that we can say are out breaking convenient as we time the fatalities associated with the injection. If you go back and you look at the laboratories that actually have been doing allegedly the Monkeypox work you find that you have the perfect formula to cover with new outbreaks the deaths from the injection. We are manufacturing a cover story in the form of a new epidemic.

The interesting thing about that is that if you sit back and say the guy who wrote all the checks for this, Dustin Mosquitz, what's in it for him? Because he's the guy who wrote the check for Event 201. He's the guy who wrote the check for the NTI study on Monkeypox. He's that guy. Well you have to ask, so Dustin, what on earth could possibly motivate you to be so interested in Monkeypox? And it turns out the answer is very simple. It's called Sherlock Biosciences. Because Sherlock Biosciences interestingly enough is the company that has the emergency use authorization for the first time in human history to edit the human genome using CRISPR technology and they got that EUA under the cover of COVID-19. So is there any surprise that Dustin is putting into the scenario for the public to now take on board that Monkeypox is a vaccine resistant pathogen? Not a surprise at all because he never wanted the world to accept a vaccine platform. He wanted the world to accept CRISPR. And he has set the whole world up to fall for it perfectly. And no one is talking about it, nobody.

What is CRISPR?

Yeah, that's a great question we should be asking that. What that is is this palindrome repeating sequence where you go into DNA or RNA and you clip out sections or clip in sections and you edit, literally edit, the gene of the human or the gene of whatever the eukaryotic or prokaryotic cell is or anything else is. You take a thing that is a thing and you clip in or clip out whatever you want to add or subtract from yourself. So I want you to think about this and I try to do this in a way that gives people a bit of a mental picture. This is not a technical correct picture, this is a mental picture that I want you to think about. Sure. Are you familiar with diabetics that have to have dialysis because their kidneys have failed? Of course. Imagine if in, I don't know, a year and a half or two years, we set up gene editing centres where every couple months you have to go in and you have to have blood or tissue taken out and then you have blood or tissue put back in and you're running a dynamic editing system that is your upgrade because another pathogen got released or might get released. If you look at what the World Health Organization just talked about last week in Geneva, what you find is a very fascinating conversation because what they talked about is the possibility that we could actually be responding to planned epidemics. Did you hear what I just said?

Not actual epidemics. And it was the United States government who amended the IHR 2005 guidelines in their proposed amendments that actually took out the fact that we at least have to have a recognized pathogen. Now it can be for a recognized or an anticipated epidemic. We're going to be fascinating to just tell people that on Thursday we're thinking that it's probably going to be a swine flu so go line up and by the way, you're going to have this very interesting RFID chip or you're going to have something else that's going to be embedded and before you go to the grocery store, before you get on a bus, before you get on a plane, before you get anywhere else, we're going to go ahead and read the chip to make sure that you're not an 'at-risk crazy' who hasn't gotten his latest upgrade. I'm letting people know this because until we actually realize this is a felony criminal conspiracy.

This is racketeering. This is domestic terrorism. These are things for which felony laws exist. These are things for which the prison terms are minimum 99 years and if it's an institution that's promulgating those things, it's \$100 million per count violation fine. That's what we should be focused on because the fact of the matter is since the 2003 Euro Talks conference, I can sit here with absolute certainty and say that we saw a world in which we knew that if we were going to manage a population and that means manage its numbers and manage its behaviours, we realized that the biological threat was far more valuable than the nuclear threat. What we'll do is we'll use the invisibility of a pathogen to bring the world to its knees. As Kim often says, and I know as an Australian, you've heard the song enough, 'Rather die on your feet than live on your knees'. This is a time when people really need to stand up and really pay attention because we are on the verge of the cover-up of all times. According to the Pfizer CEO this can lead to the loss of half of the world's population.

It's right out there and it seems permission-based. In the spiritual realm, permission-based, I tell you something and I'm looking for an acceptance from you. For example, the world is overpopulated. They want us to think the earth is overpopulated. That way when we give voice to that, we're volunteering ourselves to be a sacrifice. You don't realize that that's what they're doing, but that's exactly what they're doing.

That's the reason why we have to have these conversations. These conversations are the most important we can have right now because what we have to realize is that this entire thing is programming the public to accept the genocide of global proportions. I made a commitment at the very beginning of this to stay within the four walls of the laws as we have them today. I've only asked for the laws to be upheld. If we have laws, if we have what we call fair play, then let's actually play by the rules. The courts across the board made an unambiguous declaration that we were in a public health emergency and that the World Health Organization and the CDC were the only arbiters of what the facts were, and so you could not argue the facts. Gates represents 88 percent of the donation to the World Health Organization from donor organizations and agencies. By any definition, that's a controlling interest. They had no problem going after osteopaths and chiropractors and people who were advocating for zinc or hydroxy-chloride, and they were shutting people down. They were taking people's licenses. The deceptive medical practice's law was very much in play.

So I think we're going to get different pathogens. We already see the NIFA craze that was going on in India, and we've got a bunch of other toxins that are being discussed. Apocalypses have been overrated every time they've been promoted, and by the way, human history is filled with apocalypse forecasts, and they all suck. We forget that we have a conscious role to play in this, and if we give the frequency of evil the carrier frequency on which it can transmit, guess what will be transmitted? Evil. I decided to swing the pendulum even further towards I'm going to stay absolutely laser focused on the criminality of what was happening, and as I've said in numerous interviews, and as I continue to say, we have to go back to 1913 to understand this crime, and specifically what we have to do is we have to look at the Rockefeller Foundation, and then a few years later the Wellcome Trust, which became the colluding parties that authorized the idea of allopathic medicine becoming the agency through which behaviour modification will be done through medicine. Remember that the Flexner report had come out, and it basically said that if you had another way of healing, other than the industrial pharmaceutical way of healing, it was going to be deemed quackery, and we were going to throw it out the window, shortly thereafter you had the Wellcome Trust being set up, and if you look at the Wellcome Trust going into the Second World War, it was very explicitly the commercial offense of the United Kingdom on the German Pharmaceutical Chemical Industrial Complex, so to the point where if people want to, they can go back and they can look at literal battle plans, I don't mean metaphoric, actual battle plans drawn by the Wellcome Trust on how you invade Germany to take out the pharmaceutical manufacturers and the chemical manufacturers of Germany. So when I say it was a battle, I'm not metaphoric in this, there's actually archived documents that show you that they had battle plans about how to take out the various chloroquines and the various drugs for malaria, the aspirins, all kinds of things, and it's bizarre to look at this. Obviously, cocaine, one of the very major pieces of that pharmacopoeia back then, which was an enormous part of the business of the pharmaceutical industries in the late 20s and early 30s, and so if we don't go back in time, we actually miss the point that the Rockefeller Foundation and the Wellcome Trust became the organizing entities, which ultimately in 1947 put the World Health Organization on the map.

But what's really interesting in that is in the charter of the UN-affiliated organizations for the World Health Organization, they wrote into the charter the absolute liability shield from all criminal prosecution in perpetuity for any person associated with the World Health Organization and any of its activities, where it quite specifically goes down to the level of saying you cannot be prosecuted

for any crime of any manner in any way as long as you do it under the umbrella of the World Health Organization. It's important to realize that when we talk about the World Health Organization, we're not talking about an institution of the United Nations. We're talking about a criminal conspiracy that was put in place by two foundations who had a commercial interest in building a criminal liability shield for themselves. That's what it is. Never was a health organization, it was a criminal organization. And by criminal, I literally mean that under the Clayton Act in the United States and under the Sherman Act in the United States and under the Competitiveness Laws of Europe, what they did was a crime.

They colluded, they price-fixed, they did all of the things which were antitrust violations but put it under the umbrella of public health and everybody's supposed to go, oh, they're doing it for the good of humanity. Except when you look at the actual financial statements of the World Health Organization, you find out that by 1950 and then again in 1955, the singular focus of the World Health Organization was, are you ready for this? Vaccine promotion. We have the Director General of the World Health Organization going one step further and saying, and I'm quoting, this is about population control. Now, what does that mean? That means that when we're taking orders from the World Health Organization, we're not. And fast-forward to the Gates Foundation, which most people don't realize, was an undisclosed settlement between the U.S. Department of Justice and the Gates convicted felony antitrust violations. This was not, there was an allegation Microsoft did bad things. This is a, they were convicted of antitrust crimes. Quite mysteriously, the Gates Foundation just shows up and instantaneously starts laundering money into, are you ready for this? The World Health Organization. If you look at the financial statements beginning with the Gates Foundation, when it was established, you start seeing an anomaly. It used to be that UN-associated organizations, and specifically the World Health Organization, had two line items for most countries. The country through an organization like the State Department or through a line item budget would allocate money to the World Health Organization. And then there's the Corporation for the same country, and there's another allocation coming from there. But with Wellcome Trust, Rockefeller Foundation and Gates Foundation, and the minor players like the Bloomberg Foundation and a couple others now, but mostly the top three, suddenly we actually have the formation of what we called the Global Preparedness Monitoring Board. Who's sitting on that? Dr. Elias from the Gates Foundation, Anthony Fauci from NIAID, Jeremy Farr from the Wellcome Trust. I mean, this is a criminal conspiracy. And I'm not saying that from the standpoint of conspiracy theory, I'm saying that from the definition of what it means to be a criminal conspiracy. And so if you ask the question, which is a legitimate thing to do, was the FDA, was the CDC following orders from the WHO, the answer is, "Almost". But who were they really following orders from?

And that's where you get into the nasty answer, which is the answer was that interlocking directorate, that violation of antitrust laws, that corporate machine, not health, not, you know, we're out for the good of humanity. That corporate criminal conspiratorial organization that was guilty at the time of racketeering was guilty at the time of interlocking directorates, all felonies, was guilty at the time of price fixing another felony, which was guilty at the time of actually suppressing commercial alternatives, which is called market allocation, another felony, that criminal organization announced that it was going to take over the world, and they did. But we have to name the names. It wasn't just the World Health Organization.

Anybody thinks that Tedhros is smart enough to pull this off? He's delusional. He's a puppet. And there's a giant stick up his ass, which is what's making his mouth move. But who's moving the stick for the puppet? And that is, Wellcome, Gates and Rockefeller. By 2023, which is kind of where we are right now, Gates represents 88% of the donation to the World Health Organization from donor organizations and agencies. By any definition, that's a controlling interest. So is it independent? No. Is it the World Health Organization non-profit in Switzerland? No. This even violates Swiss law. Everything I'm saying is a violation of Swiss law. If we think about how bizarre it is that we have the, essentially the extension of the Carnegie Foundation's Eugenics Office, which they put at Cold Spring Harbor Labs back in the early 1900s, the continuation of that with the explicit inclusion of that as an agenda in the 1950s when the World Health Organization gets off the ground. The ongoing nature of Bill Gates getting up and talking about how there's too many people on the earth and Bloomberg and others getting up and saying we need to figure out how to control populations. In 2011, when we had the decade of the vaccine's publication come out of the Global Preparedness Monitoring Board, we had a very explicit statement that said that if we have vaccinations where we need them, we will actually see potentially as much as a 20% reduction in the population on earth. Those are not allegations. Those are stated objectives. For example, the world is overpopulated. They want us to think the earth is overpopulated. The World Health Organisation (WHO) has declared Monkeypox a global public health emergency, triggering emergency powers to drive vaccine sales that benefit big pharmaceutical companies with ties to the organisation. This decision serves corporate interests rather than public health. Regulatory agencies that are meant to protect the public fall under undue influence from the industries they regulate. The WHO is a corrupt organisation that is designed to funnel taxpayer money to its billionaire donors. Australian taxpayers gave \$30 million to the WHO last year, likely as a show of loyalty.

Transparency is lacking. Major donors include GAVI, a vaccine alliance funded by corporations tied to predatory giants like BlackRock and Vanguard, who also own large shares in pharmaceutical companies. The WHO's Monkeypox emergency, declared solely by its director-general, Tedros Ghebreyesus, highlights the unchecked power of the position. This decision created a market for four already-approved vaccines linked to companies backed by BlackRock and Vanguard, ensuring massive profits for their shareholders. A new Monkeypox vaccine is expected soon, likely fast-tracked by compromised regulators like Australia's Therapeutic Goods Administration (TGA).

The WHO previously tried to raise alarm over Monkeypox but found little public concern, so they rebranded it as "MPOX" to push vaccine sales. This benefits the predatory billionaires who control vaccine companies, funnel money to GAVI and the WHO, and fund political parties, including Australia's Liberal and Labour parties. Recent revelations show Anthony Fauci concealed plans to engineer a more deadly and highly transmissible MPOX virus. This "gain-of-function" research has pandemic potential and should be stopped immediately. It's troubling that Australia's CSIRO was involved in gain-of-function research for COVID-19, yet faces no consequences. The WHO and the TGA have failed in their regulatory duties, serving political agendas rather than public interest. During COVID, the TGA prioritised government control over public health, and there are concerns the same will happen again with MPOX.

Every Monkeypox case should be verified through public lab tests, especially as redacted data was used to justify COVID measures that harmed public health.

The UN's World Health Organization, the WHO, has declared monkeypox a public health emergency of international concern. This triggers WHO emergency powers to drive vaccine sales to financially benefit big pharmaceutical companies that donate to the WHO through their other commercial and ownership interests. The first thing a house of review like our Senate should do is ask, 'Is this a legitimate decision?' The answer is: it is not, no. The UN WHO has succumbed to regulatory capture—a troubling development in governance. That may plunge Western society into serfdom under large corporations.

Regulatory capture occurs where a regulatory agency mandated to oversee and enforce rules to protect the public interest ends up under undue influence from companies with vested interests such as the entities it's meant to regulate or special interest groups. This can result in the agency making decisions that prioritise the interests of these parties over the broader public interest. The New South Wales government lists six areas for regulatory capture: adherence to public interest principles; organisational culture; structure; processes; transparency; and staff experience. The WHO fails all six.

I've often spoken about the corruption, cronyism and illegal behaviour of the World Health Organization; some of my WHO speeches are on my website. The WHO fails to hold staff accountable for misbehaviour, including rape and sexual assault. Its own investigators conclude the WHO is 'rotten with rapists'—their words. It is a failure of organisational culture and of staffing quality. The WHO is a corrupt organisation whose decisions benefit its billionaire sponsors with substantial health interests. The scam is simple: take a disease that's around for generations—firstly the flu, and more recently bird flu and now monkeypox; plant scary stories in a media desperate for clickbait articles; use the media driven fear to declare a pandemic; and then—payday!—mandate vaccines financially benefiting the billionaires that funded the media scare. This betrays the public interest.

The WHO is a con, a fraud and a criminal enterprise designed to transfer wealth from taxpayers into the pockets of their billionaire donors and owners. It is an organisation to which Australian taxpayers gave \$30 million last year despite them having \$8 billion in financial assets; that donation was likely more about fealty than financing. Identifying the WHO's donors is difficult since its annual accounts show 32 per cent of donations as 'other'—another failure of transparency. One of the WHO's major donors is GAVI, the globalist vaccine alliance of international academics, bureaucrats and pharmaceutical companies funded through corporate donations from companies whose share registers feature investment funds like BlackRock and Vanguard. They feature on big pharma share registries; they own big pharma. If Australia had racketeering laws this arrangement would be illegal. This is a failure in structure.

The Monkeypox declaration came from the WHO director-general, Tedros Ghebreyesus, acting alone. The process for making such an important decision is not meaningfully regulated and gives Ghebreyesus too much power to direct a worldwide health response. This is a failure of process, and it's deliberate. The proclamation is designed to create an international market for new Monkeypox vaccines.

The WHO already have four approved vaccines for Monkeypox: Cidofovir, distributed through Pfizer; Brincidofovir, manufactured and distributed through Chimerix, whose controlling shareholders include Vanguard and predatory wealth fund cronies; TPOXX, from Siga Pharmaceuticals, with shareholders BlackRock and Vanguard; and ACAM2000 from Emergent Biosolutions, whose largest shareholders are—wait for it—BlackRock and Vanguard. With these drugs the world's predatory billionaires have decided it's time for another fundraiser. All four drugs are off-label use—so, any day now, expect a killer new vaccine for Monkeypox to be given the hosanna palm frond parade through our disgraced regulators like Canberra's Therapeutic Goods Administration, the TGA.

The WHO tested this scam a few years ago with a minor media fear campaign that discovered the public didn't take something called Monkeypox seriously. So they rebranded it as MPOX. Amusingly, they claimed the name Monkeypox was insulting to monkeys; monkeys have feelings too, you know! So MPOX is Monkeypox rebranded to sell more vaccines from vaccine companies who funnel the profits to the world's predatory billionaires—those same billionaires who own the corporations that donate to GAVI and the WHO, as well as fill the coffers of political parties around the world, including massive donations to both cheeks of the Liberal-Labour Uniparty in this country.

Last Tuesday, American congressional investigators revealed that, for nearly nine years, Anthony Fauci concealed plans to engineer a pandemic-capable MPOX virus with high transmissibility and a case fatality rate of up to 15 per cent. That's homicide. The gain-of-function project proposed through NIAID in America from virologist Bernard Moss was to splice genes conferring high pathogenicity from the clade I virus into the more transmissible clade II virus. The new chimeric virus or combined virus could have retained up to a 15 per cent fatality rate and a 2.4 reproductive rate—a measure of transmissibility—meaning, on average, every sick person could infect up to 2.4 other people, giving it pandemic potential. It's marvellous, what it's designed to do!

We know gain-of-function research produced the COVID-19 virus. Is this Monkeypox outbreak also man-made?

Gain-of-function research serves no useful purpose and should be terminated immediately. It's deeply troubling that Australia's CSIRO admitted and bragged about its involvement in gain-of-function research that produced COVID-19. And now an online meme simply says: 'They're doing it again because you didn't punish them last time.' That's truth indeed.

The WHO fails all six elements of regulatory capture and so does Australia's Therapeutic Goods Administration, the TGA. The TGA is not acting in public interest, which former New South Wales deputy ombudsman Chris Wheeler considers fundamental to representative democratic government. The TGA may claim that, during COVID, it was caught between the parliament, its direct employer, and the wider public. It chose to serve the government's need for air cover for controls decided on political, not medical, grounds. The TGA should have read the findings of the 1990 WA Inc royal commission, which found: The institutions of government and the officials and agencies of government exist for the public, to serve the interests of the public.

That's clear. Yet, during COVID, the TGA chose a different path: to support their own agency, to the detriment of the public. What will the TGA do this time, with Monkeypox? Monkeypox is transmitted through direct contact from sexual activity or intravenous drug use. A Philpot scientific study found 98.7 per cent of infections resulted from gay male sexual transmission. Transmission can occur through direct personal contact of the infected site. Infected animals can spread the disease.

Asymptomatic spread, though, is, like COVID, an assertion with no evidence. The clade Ia variant of Monkeypox can affect children. The clades currently circulating, though, clade Ib and II, have not been proven to infect children.

Australia has two Monkeypox vaccines approved for over-18s. Both are off-label repurposed drugs approved for smallpox. JYNNEOS from Bavarian Nordic uses Cidofovir, which I mentioned earlier, as the active ingredient. Bavarian Nordic have an application in to America's Food and Drug Administration to give this vaccine to children aged 12 to 18 and are in early testing to support their application to extend use to children aged two and above—two and above! Why does a child need a vaccine against a disease that's predominately only transmitted through sexual contact or intravenous drug use? The case for a Monkeypox vaccination program must be a very high bar for any person who does not engage in risky sexual activity.

TGA's website data from the 2022 Monkeypox round of vaccinations in Australia shows 3,163 adverse events per 100,000 vaccinations—a staggeringly high three per cent. I note a study published in the journal *Frontiers in Medicine*, with authors from the University of New South Wales, entitled 'Autoimmune blistering skin diseases triggered by COVID-19 vaccinations: an Australian case series'. This report found that COVID-19 vaccination either caused the recipient to develop autoimmune blistering disease or made the recipient's existing condition worse. The cases are extremely rare, and, for once, I can agree with the TGA. I alert Australia to the chance that these outbreaks of a related disease could be mistaken for Monkeypox. I note that autoimmune diseases and shingles—that is, herpes zoster—can intersect, and both are side effects of the COVID vaccines. If the Senate is going to be called on to support a Monkeypox response, then it's essential every case is verified through publicly disclosed laboratory testing.

Page after page of redacted data was used to support COVID measures and the damage to public health is undeniable. It's homicide. 'Safe and effective' was not one lie; it was two. People are not believing the UN World Health Organization MPOX narrative.

The time for blind trust is over. We're now in the age of 'prove it'.

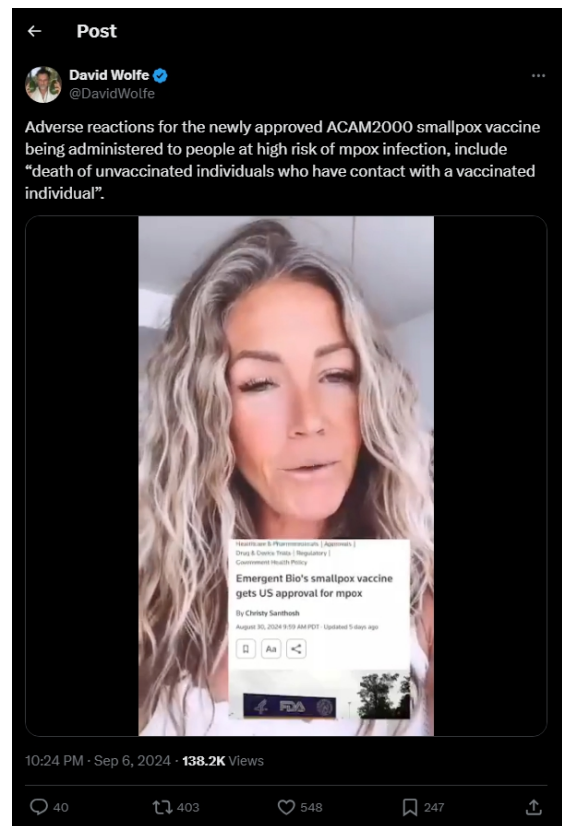

Transcript on Freedom

As a servant to the people of Queensland and Australia, I speak tonight on freedom. PFIZER'S 75 YEAR RULE

There was significant concern about the initial proposal to keep the data secret for 75 years. Many people, including public health experts and transparency advocates, felt that such a long delay would undermine public trust in the vaccine and the regulatory process. They argued that timely access to the data was crucial for independent review and to reassure the public about the vaccine's safety and efficacy.

The court's decision to expedite the release of the documents was seen as a victory for transparency and public accountability. It helped address some of the concerns by making the information available much sooner. The "75 rule" relates to a legal case involving the release of Pfizer's COVID-19 vaccine safety data. Initially, the U.S. Food and Drug Administration (FDA) proposed a timeline of 75 years to fully release all the documents it used to license Pfizer's COVID-19 vaccine. However, a federal judge ruled that the FDA must release the data much sooner, within about eight months. This decision was significant because it aimed to increase transparency and public trust in the vaccine approval process.

The Cumulative Analysis of Post-Authorization Adverse Event Reports of BNT162b2 (Pfizer-BioNTech COVID-19 vaccine) was prepared by Pfizer and released in April 2022. This report details the adverse events reported up to February 28, 2021. It includes a comprehensive list of adverse events, their frequencies, and Pfizer's analysis of these events. The **Cumulative Analysis of Post-Authorization Adverse Event Reports of BNT162b2** was initially intended to be kept confidential for a period of **75 years**. Appendix 1 of the **Cumulative Analysis of Post-Authorization Adverse Event Reports of BNT162b2** lists the **Adverse Events of Special Interest (AESIs)**. These are specific adverse events that are closely monitored due to their potential significance or severity.

- Some of the AESIs mentioned include:
 - Anaphylaxis:** Severe allergic reactions that can occur shortly after vaccination.
 - Myocarditis and Pericarditis:** Inflammation of the heart muscle and the lining around the heart, respectively.
 - Thrombosis with Thrombocytopenia Syndrome (TTS):** A rare but serious condition involving blood clots and low platelets.
 - Vaccine-Associated Enhanced Disease (VAED):** A theoretical concern where vaccinated individuals might experience more severe disease upon exposure to the virus.

It says these AESIs are being closely monitored to ensure the ongoing safety of the vaccine. It further says that about the monitoring outcomes of Adverse Events of Special Interest (AESIs) related to COVID-19 vaccines. Regulatory agencies like the Medicines and Healthcare products Regulatory Agency (MHRA) in the UK and the Food and Drug Administration (FDA) in the US regularly publish safety updates and reports on their websites. These reports include data on reported adverse events, ongoing safety monitoring, and any new findings. Pfizer concluded that the findings from their signal detection analyses are consistent with the known safety profile of BNT162b2 and that the cumulative post-marketing experience confirms a favorable benefit-risk balance
