
1) Fabian Picardo's habitual tendency throughout The Policing The Corona State, has been to scattergun all manner of spurious statistics towards the people of Gibraltar, and so with his incessant official fear-mongering contained within his press statements, it only seems right and fitting to reflect back to him, how he himself invariably came across to us, from the moment he sent Gibraltarians into lock-step with the globally planned lockdown process, as a precursor for enabling his JABS2GIB objective to go full throttle overdrive.

- 2) In 2020, the people of Gibraltar, as part of their daily staple diet of Fabian's incessant fearmongering, got haphazardly scatter-gunned with all manner of disjointed and discontinuous Covid-19 statistics. This prolonged and incessant habit rendered analysis of government published statistical data meaningless in a comparative context. Was this a deliberate ploy on Picardo's part? From examining what follows in part one of this crime report, it would certainly seem to be the case.
- 3) To begin with, let it be first said that obtaining reliable published data on mortality and morbidity rates in Gibraltar in recent times has proven to be most problematic, if not damn near impossible to do. Neither the Government, nor the Gibraltar Health Authority appear to have a continuous uninterrupted system in place for putting local annual mortality and morbidity rates into the public domain. Such patterns occurred in many of the nations of the world. Yet, it was tiny Gibraltar that made global headlines, after being one of the first nations to roll-out the vaccine to its people, which remarkably coincided with a huge spike in deaths. This happened in the immediate aftermath of the start of the Pfizer Vaccine roll-out from 10th January 2021 onwards.

- 4) That's when, ever so conveniently for the government, published statistical data in a comparative context ceased to be. Therefore, the overall picture, ever since that pivotal crisis moment in the so called "saddest month", remains blurred, undoubtedly purposefully so. What exactly has the government been hiding from the people of Gibraltar? The wider purpose of this crime report is to undertake exploratory data analysis, warts and all. Part one provides a glimpse of the government's actions as they themselves saw fit to helpfully document on the government on line facilities.
- 5) Owing to the newly imposed universal fixation for attributing all deaths to Sars Cov-2, mortality data in a comparative context ought to have been paramount. Instead such data when most needed was nowhere to be seen. This practice ran contrary to rhetoric of the Chief Minister who had in March 2020, waxed lyrical about not keeping anything from the public at a time leading up to the Covid-19 lock-down measures. Death rates per 1,000 persons were seen as a key indicator in the Abstract for Statistics 2016, and that year happened to be the last occasion when such data in a comparative context got officially published. The sudden surge in excess deaths subsequently seen across the globe is on an unprecedented scale, and governmental institutional denials notwithstanding, many notable medical practitioners have since attributed this excess deaths phenomenon to be a direct consequence of vaccine roll-out.
- 6) The chart below illustrates the unsatisfactory state of affairs. Essential data, which is being kept from the public here, is nevertheless seeping through into United Nations data repositories, such as "Our World in Data". In the absence of official published data from either the Government, or the Gibraltar Health Authority, the six datasets on display in the chart below, supposedly measuring the same metric, all hopelessly contradict one another. At best this is a most unprofessional state of affairs; at worst it is indicative of deliberate government obfuscation in order to throw the public off the scent of the actual excess death experience across the Rock, and all over the rest of the world. Something seems terribly amiss here. The Global Data resource and The United Nations World Population Prospects resource, both hold data on Gibraltar which can be justifiably described as utter nonsense. The data which seems most reflective of reality comes from the Our World in Data (1) repository, which would naturally lend itself for much needed analysis in a comparative context were it not for the fact that no data exist for Gibraltar since 2021.



WHY ARE THERE DISCREPANCIES IN REPORTED DEATH RATE DATA?

The GBC reported these numbers given by the government on 4 Feb 2021 in "First look at excess deaths - 78% increase in three month period to January 2021 compared to previous 10 years".

"January was the deadliest month, with 89 deaths recorded. The average number of deaths in the month of January over the previous decade was 31. 2021 saw an **increase** of almost 187%."

Which dataset is reliable? How can we TRUST any of them? Why is there complete silence on the data?

7) The Chief Minster stands accused of wanting to shape the narrative so that he could enable The One Truth of The Globalists plan to use poisonous injections to depopulate the world. On 17th March 2020, The Chief Minister declared a Public Emergency and in a cliché ridden speech announced the following:

"Today We Have Crossed The Rubicon".

"If it isn't in the established national media and the National Broadcaster, do NOT believe what you are reading or what you are told."

"Do not fall for irresponsible fake announcements in this or any other respect."

"WE ARE KEEPING NOTHING FROM YOU."

"WE WILL NOT KEEP ANYTHING FROM YOU."

"TRUST US AS YOUR SOURCE OF INFORMATION."

Given Fabian Picardo's previous lies and hollow proclamations it seems only right and fitting, at this point in the proceedings, to call upon the Chief Minister and Helen Carter to jointly disclose to the people of Gibraltar, without any undue delay, the actual number of monthly deaths in Gibraltar, broken down by age, and by gender between 2016 to June 2024.

- 8) As early as 2nd April 2020, it was announced in a Government Press release that there had been a <u>first death</u> in Gibraltar from suspected Covid-19. Please note that it was stated that a post mortem should be carried out, rather than necessarily would be carried out. However, the <u>first actual confirmed death</u> from Covid-19 was only reported over seven months later on 11th November 2020. By 22nd November 2020, the cumulative deaths from Covid-19 had reached <u>five</u>. It was not made at all clear whether post mortems or autopsies were carried out.
- 9) On 8th December 2020, the UK became the first country in the world to deploy an approved COVID-19 vaccine. The Pfizer-BioNTech vaccine became the injection of choice. Within one year, 120 million doses of a poisonous bioweapon had been administered across the UK.
- 10) Meanwhile in Gibraltar, by the end of December 2020, the year of the pandemic outbreak, the cumulative number of deaths from Covid 19 in Gibraltar had reached seven. Deaths from flu were nolonger to be seen anywhere. In the regular governmental press releases, there were no names assigned to the deaths announced in the press releases, just signs in abundance of an obsession with bean-counting every coronavirus business metric imaginable save for the most important indicators of all death rates.
- 11) In spite of the implementation of the government Covid-19 press release system, amidst all the government's expressions of growing concern about the rise in Covid-19 cases, it transpired that the <u>next death</u> announcement wasn't made until 12th January 2021.
- 12) Yet on this date, which came after the arrival of the Pfizer vials from the UK, a government press release informed us that the cumulative deaths had reached <u>eighteen</u>. Strangely, in not one of the interim press releases, had there been any mention of any of the ten or so Covid-19 deaths which had occurred since the start of the new year. During this lockdown period, the system of reporting deaths to the public was at best becoming sloppy, at worst downright confusing. The names of the deceased were not made known in the press releases.
- 13) On 13th January 2021, the next government press release told us that there had been <u>three</u> <u>further deaths in ERS</u>. It went on to say that the cumulative death toll had now reached 23. The press release also said all will be reported on in tomorrow's statistics as deaths from Covid-19. This disjointed reporting system easily serves to confuse as three plus eighteen equals 21, not 23.
- 14) On 14th January 2021, the next government press release simply informed us of <u>two more</u> <u>Covid-19 deaths</u>.
- 15) On 15th January 2021, the next press release informed us of the loss of five more residents bringing <u>the total losses up to 30</u>. In the Chief Minister's statement of the same date, referring to the COVID Platinum Command Group, a scattergun of two-dozen meaningless statistics, all devoid of any kind of comparative context, gets unleashed, as the crisis worsened.

<u>"Most importantly, I am able to report to the House that NO DOSES HAVE BEEN</u> <u>WASTED AT ALL!</u>" It was announced that the R number was 0.77. These were incongruent messages coming from the lips of The Chief Minister. On 16th January 2021, the next press release informs us of <u>four</u> further COVID-19 deaths.

- 16) On Monday 18th January 2021, as the death toll rose to <u>45</u>, the Chief Minister's Script was entitled "Our Saddest Day". When all this is over, we will hold an interfaith service, for all Gibraltar together, for all our creeds, beliefs, and none, to remember all those whom we have lost. It is not clear if any such Interfaith Service was ever subsequently held.
- 17) However, in November 2023, Fabian Picardo and Sir David Steel (alias Cassius and Brutus) went to see the world's leading pusher of the kill-shots, namely the Jesuit Pope Francis, who declared that The Rock's <u>Interfaith</u> harmony must be treasured.
- 18) Pope Francis needs to be mentioned here as he has been a major global advocate for Covid-19 vaccination, emphasizing its importance as an "act of love." He has encouraged people to get vaccinated with approved Covid-19 vaccines, highlighting that they bring hope to ending the pandemic. In a video message, he praised the work of researchers and scientists in producing safe and effective vaccines, and he prayed that each person can make their own small gesture of love by getting vaccinated. The Vatican's doctrine office has also stated that it is <u>"morally acceptable"</u> for Catholics to receive Covid-19 vaccines based on research that used cells derived from aborted fetuses. The ever insightful and thought provoking former Papal Nuncio, Archbishop Carlo Maria Viganò, correctly branded Pope Francis as a <u>Servant of Satan</u>.
- 19) On 19th January 2021, as two further Covid-19 related deaths were announced, bringing the total to <u>47</u>, the Chief Minister sought to reassure the populace by saying that <u>"Little vials of hope have given us a path out."</u> Other sections of this report will prove that to be nothing but a pathological lie.
- 20) On the 20th January 2021, as six further Covid-19 related deaths were announced, bringing the total to <u>53</u>, the <u>Coroner</u> of Gibraltar and the Stipendiary Magistrate, Charles Pitto, instead of being allowed to determine the cause of the sudden surge of all these deaths, or call for autopsies, amidst the poisonous bioweapon roll-out on The Rock, had the author of this report, thrown in prison. The crime in question was for the act of refusing to wear a health-harming face-mask, in his unlawful courtroom.
- 21) On 21st January 2021, as six further Covid-19 related deaths were announced, bringing the total to <u>59</u>, it was stated the Government received a Coroner's report confirming that on 7th January 2021, a woman aged 60-65 years old, who had a history of underlying medical conditions, died of COVID-19 pneumonitis and myocarditis. This will be recorded in today's statistics as a death from COVID-19. One wonders how many Coroner's reports in Gibraltar were actually undertaken,during this Covid-19 era.
- 22) On 22nd January 2021, The Chief Minister briefed <u>UK parliamentarians</u> on Covid. Sadly, UK hero Braveheart Andrew Bridgen MP, would doubtless not have been invited to the briefing owing to what he knew and what he would say.
- 23) Again on Friday 22nd January 2021, The Chief Minister in a Press Conference said the following:

"Since I last addressed you on Monday, there have been <u>14</u> more confirmed deaths from COVID-19. Of these seven were residents of Elderly Resident Services." He went on to say: "Today, we suspect another death in the Community which is being investigated by the Coroner, as likely also being from COVID-19."

This further raises the question as to whether or not any of the sudden deaths occurring in the ERS were ever likewise subjected to post mortems, and if not, why not?

- 24) On 23rd January 2021, The Government deeply regrets to confirm 3 deaths yesterday afternoon and evening from COVID-19. This brings the total number of COVID-19 related deaths in Gibraltar to <u>62</u>.
- 25) On 24th January 2021, it was stated that HM Government of Gibraltar deeply regrets to confirm the death of a resident of Elderly Residential Services from COVID-19. This brings the total number of deaths related to COVID-19 in Gibraltar to <u>63</u>.
- 26) On 25th January 2021, it was stated that HM Government of Gibraltar is deeply saddened to confirm 2 further deaths from COVID-19. Both will be recorded in today's statistics as deaths from COVID-19. The total number of deaths related to COVID-19 in Gibraltar is <u>65</u>. The Chief Minister went on to declare that "*Gibraltar has now administered the first dose of the vaccine to around 1/3 of the population. This is extremely welcome news and gives us some light in these dark days.*"

- 27) On 26th January 2021, it was stated that The Government is extremely saddened to confirm 4 further deaths in our community related to COVID-19, bringing the total to <u>69</u>. The Chief Minister urged us to wear masks and get vaccinated when the GHA offers it.
- 28) On 26th January 2021, the Chief Minister offered condolences and solidarity on behalf of the rest of the government and the people of Gibraltar to Boris Johnson, on the day that UK deaths from Covid-19 exceeded <u>100,000</u>.
- 29) On 27th January 2021, it was stated that The Government deeply regrets to confirm a further death from COVID-19, bringing the total number of deaths related to COVID-19 in Gibraltar to <u>70</u>. On the same day, it was stated in the <u>next press release</u> that "*The Gibraltar Health Authority can confirm that there is no evidence at all of any causal link between these six deaths and the inoculation with the Pfizer vaccine.*" It was further stated that The Chief Minister of Gibraltar arising from inoculations with the Pfizer vaccine. It is untrue to suggest otherwise and people should not believe the dangerous nonsense being put out on social media by discredited individuals that suggests the opposite."
- 30) Sadly, the identity of these so-called discredited individuals never got mentioned. Whereupon, Picardo asserted that "Immunisation is the best and only strategy to safely emerge from the difficulties that the pandemic has created for nations and communities around the world. In partnership with the United Kingdom, we will turn the corner against the virus." Picardo never once disclosed to the public that the pandemic was planned.
- 31) On 29th January 2021, it was stated that the priority of the Covid-19 vaccine had not changed since the start of the programme. Initially, people over 70, younger people who were very clinically vulnerable, residents and staff of ERS, and health and care staff were vaccinated. Appropriate in-patients in St Bernard's and Ocean Views were also vaccinated in this cohort. On the same day it was further announced that phase one of the vaccination programme was complete. Confirmation has now been received from the UK that the next delivery of vaccines to Gibraltar is scheduled for Saturday 30th January, meaning that phase II of the GHA programme will commence on Sunday 31st January. The following, unsubstantiated or fraudulent statistical claims were again parroted to lend support for the Government's shaky position:

"The public are advised that once they have received the first Pfizer BioNTech vaccine, the body will start to produce an immune response, but this takes time. Current evidence shows that up to 89% of people will have developed some immunity to the virus that causes COVID-19 by the time of their second dose. The second dose is designed to both give longer immunity from the virus, and also to raise the immunity level to 95%."

- 32) In the next press release, again on 29th January 2021, the government confirmed two more deaths from Covid-19. It was stated that the total number of deaths related to COVID-19 in Gibraltar is now 73. The press release continued: "HM Coroner has today confirmed that on 22nd January a woman aged 80-85 years old died of COVID-19 pneumonitis and acute myocardial infarction."
- 33) In the Press Conference of 29th January 2021, Fabian Picardo made reference to further statistical data on the deaths from Covid-19 during the "saddest month". Examples follow:
 - 12,860 inoculations will have been administered by close of business today.
 - NOT ONE DOSE on a 6 dose per vial basis has been wasted.
 - This loss of life cannot EVER be forgotten.
 - Overnight the total number of tests for COVID carried out in our community yesterday was 1,223.
 - The R rate is now calculated by the Director of Public Health to be below 0.5.
- 34) In the Press Conference the Chief Minister fielded some refreshingly brave questions about the vaccinations from Jonathan Scott from the GBC.

PICARDO'S PRETZEL LOGIC WITH THE PRESS?

GBC, Jonathan Scott [00:39:50]

We've seen Gibraltar at the top of tables comparing how different countries have been impacted by coronavirus, by covid-19, we've seen Gibraltar at the top for testing and also for now, the roll out of the vaccination programme, second behind Israel, but also sadly at the top for a number of cases and deaths. **Do those comparators weigh on you?**

Fabian Picardo: [00:40:16]

Well, I mean, as I've said before, I think it is irrelevant to do those comparisons. I mean, a lot of these things are done on the basis of extrapolations, over 100,000 people. Right. So let me tell you what weighs on me. You look at us per 100,000 people, our deaths are probably 210. We haven't got 210 dead people. We've got 73 dead people, those additional 130 people do not exist, their corpses are not there. So we don't need to preoccupy ourselves with nonsense like league tables. This is not the premiership. You know, this is reality. We have to worry about the 73 who have died on our watch in our country, not what we look like in the context of some league table for the good and for the bad. COVID-19 is not a race. COVID-19 is a problem, a public health crisis that we have to resolve in the context of our reality. And solving it in the context of our reality is what we must concentrate on, not look over our shoulders and worry about how our neighbour might be doing better than us or might be doing worse than us. Once we have done what we need to do, we need to look at how we can help others from Gibraltar and we shall certainly be doing that. But, you know, the league tables are unfortunately, in my view, a fool's errand either when we're at the top of one or at the bottom of another.

GBC, Jonathan Scott [00:49:20]

Chief Minister, if I may, a question which we've asked previously, but just maybe for an update. Any health care workers or any issue arising as a result of health and care workers or now teachers not wanting to accept the vaccine?

Chief Minister, Fabian Picardo [00:49:37]

None. I think that statistically, these are not issues which have shown themselves to be concerning in any way. In fact, I think that if you look at what's happened with the vaccine. Before the vaccine arrived, there was a lot of chatter about whether people would take it or not take it. As the news has developed and that the vaccine has arrived, I think people are forming an orderly queue, having the vaccine as soon as it is offered to them. There have been some legitimate questions, for example, issues relating to women of childbearing age, women who are pregnant, women who might be breastfeeding. And they wanted to have more information about how the vaccine is licenced for them, what evidence there is in testing in relation to the vaccine and what data is available. That has manifest itself more in the teaching profession than it has in any of the other professions, because there are more women of childbearing age in that profession and public health Gibraltar has provided some FAQs dealing with those frequently asked questions which they've detected. And as a result of pushing out that FAQ leaflet to those who have previously raised those questions, they found that they've satisfied in many instances the concerns that those people had and those people have asked to be vaccinated now that they've had their concerns resolved. And therefore, we don't have a statistically concerning number of people who might not have wished to have the inoculation. In other words, people who have had it offered but rejected it.

GBC, Jonathan Scott [00:51:03]

Your language suggests that there have been cases, even if significantly not, statistically not significant. Any policy decisions to make as a result, if I mean specifically or most definitely were they caring for vulnerable people? But I can also imagine, given the logic the government has used for postponing the opening of schools, the teachers are in a particular place to act as a vector for the transmission of the virus. Any policy decisions resulting? Chief Minister, Fabian Picardo [00:51:35]

No, the answer is no, because it's not statistically significant. If it was statistically significant, we might have to make policy decisions. But if you have numbers which are small enough that it's not statistically significant, you don't have to make policy decisions.

- 35) Under Operation Freedom, The GHA announced that in the nearly 3 weeks since, the Public Vaccination Centre at the former PCC has administered the Pfizer COVID-19 vaccine to over <u>8400</u> members of the public.
- 36) On 30th January 2021, again in announcing two further deaths from Covid-19, The Chief Minister stated: "Assume every one you meet outside of your home has COVID-19 in the way that you approach them. Remember, the best ways to protect yourself and others remain the same. Stay at home unless you really have to go out. Wear a mask in public, wash your hands and call 111 as soon as you develop symptoms. Please accept the vaccine when the GHA offer it to you. Now is not the time to give up."
- 37) On the last day of the saddest month, it was stated that: "HMGoG regrets to confirm a further two deaths in Gibraltar from COVID-19 in the past 24-hours, bringing the total number of deaths in our community related to COVID-19 to <u>77</u>."
- 38) On 1st February 2021, while being mercifully spared of Fabian Picardo's statistics, Minister for Health, Samantha Sacramento MP said, "In the second week of February the Gibraltar vaccination programme will invite 16-18 year olds who are at school/college to come forward for vaccination. Given the density of the population in Gibraltar and our many multi-generational households, combined with schools re-opening, our aim is to focus as much as possible on preventing the spread of this disease." Minister for Education, John Cortes MP said: "Young people typically do not become very unwell with COVID-19, but there is evidence that they can inadvertently spread the disease to others. Vaccinating 16-18 year olds who are at school/college will help protect young people, their teachers and their families."
- 39) On 2nd February 2021, Samantha Sacramento stated that vaccination was being offered to University Students returning to the UK.
- 40) On 5th February 2021, a minute's silence was held for <u>80</u> Gibraltarians and in solidarity with all nations of the world where COVID has taken so many prematurely. Never once was there a mention of the mounting evidence across the world about the vaccines not being safe and effective. The minute's silence was then broken by a plethora of Picardo's statistics.
- 41) By close of play on Thursday 4th March, <u>41,318</u> vaccinations against the virus that causes COVID-19 had been given by the GHA. 26,163 people have received their first dose of the vaccine with 15,155 of these people also having received their second dose.
- 42) On 19th February, The Chief Minister produces a plethora of yet more crude statistics in stating that <u>88</u> have been lost to the virus. "We have crossed the Rubicon", he melodramatically says.

- 43) On 17th March 2021, one year on from when Fabian Picardo first mentioned "Crossing The Rubicon", UK Health Secretary, Matt Hancock, described Gibraltar as the first nation in the world to complete its entire adult vaccination programme - although the delivery of doses is still ongoing. Mr Hancock made the comments in the UK Parliament, paying tribute to all Gibraltarians for their fortitude during this crisis. Meanwhile, speaking in the Gibraltar Parliament in response to a question from the GSD's Elliott Phillips, Fabian Picardo said Gibraltar was only "hours away" from completing the vaccination programme.
- 44) On 24th March 202, Government announced further relaxation of COVID-19 restrictions no active cases of COVID-19 in St Bernard's Hospital or in our Elderly Residential Services. Today is another day when we report zero new infections.
- 45) On 26th March 2021, in an article in the <u>UK Guardian</u>, and in an interview on the GBC, it was stated that more than <u>90%</u> of Gibraltar's 33,000 residents have now had two doses of the vaccine. The issues of GHA coercion to take the vaccines was raised but disdainfully downplayed. Save for the 3% or so who declined the jab, the rest are expected to receive their second dose in the coming days, igniting hopes that the territory can turn the page on a pandemic that has killed 94 residents and infected more than 4,200.
- 46) On 25th May 2021, it was announced that the GHA's COVID Laboratory has for the first time completed whole genome sequencing analysis on a current active Gibraltar case of COVID-19.
- 47) On 7th July 2021, <u>Policing The Corona State</u> got delivered to The Commissioner of The Police. The report called for the arrest of Fabian Picardo and his accomplices for their part in the poisonous vaccine roll-out programme.
- 48) On 11th August 2021, The Minister for Health, Samantha Sacramento, announced that the UK Government was supplying an additional <u>1170</u> doses of the Pfizer BioNTech COVID-19 vaccine to Gibraltar. The press release stated that this latest shipment takes the total number of doses of COVID-19 vaccine supplied to Gibraltar by the UK to approximately 80,000. It was announced that following the recent decision by the UK Joint Committee on Vaccination and Immunisation (JCVI) to approve the Pfizer BioNTech for administration to high-risk/vulnerable children aged 12-15 years, and the supply by the UK, vaccines will also be made available to children over the age of 12 who are deemed vulnerable in accordance with JCVI guidelines.
- 49) On 16th September 2021, The UK Joint Committee on Vaccination and Immunisation (JCVI) announced today that a single booster dose of the COVID-19 vaccine is recommended to be given, initially to everyone aged 50 and over, six months after their second dose of the vaccine. The press release stated that following this announcement, the Medical Director and Director of Public Health for the Gibraltar Health Authority have now recommended to the Gibraltar Government that this advice should be implemented locally. Booster vaccinations will be scheduled once the necessary supply of Pfizer BioNtech vaccine is delivered from the UK.
- 50) Dr Helen Carter, Director of Public Health for Gibraltar added: "The vaccination programme is helping to save lives and greatly reduce the hospitalisations and deaths from COVID-19. She went on to state that vaccinations are a key step in terms of helping us live with and beyond COVID-19 and allow many aspects of normal life to return.
- 51) Again on 16th September 2021, it is stated that the Government considers that the opposition's irresponsible reaction to the vaccination against COVID-19 of 12-15 year olds in the United Kingdom and Gibraltar is in the Stone Age. This is even more so after the move has been sanctioned by the Chief Medical Officers of England, Scotland, Wales and Northern, Ireland and when such vaccination has been happening elsewhere for months. It's ironic that the penalty for what they are doing is stoning to death.

- 52) In response on 17th September 2021, in the Chronicle the GSD party insisted that it was acting responsibly by highlighting different scientific views on the potential benefits and risks of vaccinating children in the 12 to 15 age group. The GSD had raised concerns about vaccinating children aged 12 to 15 against COVID-19. emphasizing the importance of providing parents and children with all scientific facts regarding the potential benefits and risks of vaccination. The GSD points to the advice of the UK Joint Committee on Vaccination and Immunisation (JCVI), which has not recommended vaccinating healthy 12-15 year-olds due to uncertainties about long-term health effects and marginal benefits. The opposition was reacting after being accused by the Government of pandering to the anti-vax lobby instead of protecting children, an accusation the GSD described as "an outrageous lie, typical of a government that only knows that style in defending itself".
- 53) The European Medicines Agency (EMA) also approved the vaccination of 12-15 year olds using the same vaccine in May of this year. This followed a study of 2259 children in this age group which found that their immune response was comparable to those in the 16-25 cohort. None of the children who received the actual vaccine developed COVID-19. The following month, in April, the EMA approved the Moderna vaccine for 12-17 year old children as well. This was based on a study of 3732 children none of whom contracted COVID-19 after receiving the actual vaccine. The result is that 68% of 12-18 year olds in France, 62% in Italy, 79.2% in Spain and 36.7% in Germany have already received one dose of the vaccine. The press release was awash with bold claims about the efficacy of the vaccines. Never once was the safety of the vaccines contemplated by the Chief Minister or Public Health Director.
- 54) On 4th October 2021, COVID-19 booster vaccine rollout begins at <u>ERS 714/2021</u>, and on 7th October 2021, it was stated that the GHA COVID-19 booster programme will also include the offer of the flu vaccine 728/2021. Dr Helen Carter, boasted as follows: "Gibraltar has done brilliantly in terms of the roll-out of the first COVID vaccination program with very high levels of uptake. Now is not the time to become complacent as we move to living with and beyond covid and the easing of some of our restrictions. Research studies are showing us that immunity after vaccination decreases over time.
- 55) Deridingly, the press release stated that it does not say much for the opposition that they should choose to politicise the vaccination programme as well as everything else that happens in Gibraltar. Their rash and misguided approach on such a sensitive medical matter can lead to serious consequences for the success of Gibraltar's fight against COVID-19 and the Opposition will have to live with the consequences of playing politics going forward. The Minister for Public Health, John Cortes MP, said: 'The benefits of vaccination against COVID-19 is even clearer now than when we started our mass vaccination campaign earlier this year. I cannot see a good reason why any parent would wish to choose not to have their child vaccinated. I am very grateful that the United Kingdom has, once again, immediately made available a stock of vaccines for our 12 to 15 year old cohort. The Ministry for Health is ready to provide the inoculations. No one should be in any doubt that taking the COVID-19 vaccine is the right thing to do."
- 56) It was further stated that vaccine rollout for 12-15 year-olds gets off to a successful start. Dr Helen Carter, Director of Public Health said: "I am delighted that we have been able to commence the vaccination programme for young people earlier than originally planned, and specifically before the mid-term break. This will help protect the overall population of Gibraltar and young people themselves from this horrible virus. This is another step along the road to helping us live with the virus. We know that the vaccine is effective in terms of preventing most of the serious consequences of this disease".

- 57) On 11th December 2021 it was stated that 10,000 doses of the Pfizer BioNTech vaccine arrive in Gibraltar. "As at close of play on Thursday 9th December our vaccination teams have delivered over 103,000 doses of vaccine, a truly remarkable effort. Over 22,000 people have now received a booster dose. Whilst this is good progress, it does mean that only just over half of the people that had the initial two doses of vaccine have received a booster."
- 58) "These additional supplies means we now have enough vaccine in Gibraltar to complete our booster programme and to continue to offer first/second doses of the vaccine to those who wish to take up the invitation, the public are of course encouraged to do so, especially before the Christmas period".
- 59) It was stated that young people aged 12-15 will be able to have a second dose of the vaccine a minimum of 3 months after their first dose. No decisions have yet been made about vaccinating children younger than 12 years of age.
- 60) Simply put, after the huge spike in sudden deaths in Gibraltar, when we look back to 2020, the year of the so-called pandemic outbreak, death rates remained normal. It was only after the vaccine roll-out that Gibraltar's death rates soared in 2021, but not before in 2020. That is both disconcerting and alarming in equal measure, so why has there been such deathly silence on the matter and why are these statistics getting hidden from the public?
- 61) Only after extensive searches, has some on-line data been found from The World Bank Group, based on the United Nations Statistics Division. The graph below shows the annual death rate per 1,000 people for both Gibraltar, Spain, and the United Kingdom respectively. Covid-19 notwithstanding, year on-year-death rates in Gibraltar between 2015 and 2020 hardly changed. They soared in 2021 which was the year of the vaccine roll-out, but have since fallen back to more normal levels.
- 62) For reasons explained in paragraph 4, because of the discontinuity of local published data, it is not possible to verify the reliability of the United Nations data set. This is far from ideal, but in a comparative context, it represents the best available data at my disposal.
- 63) Prof Ian Cumming, Chairman of the vaccination committee added: "Once again 'Team GHA/ERS' has rallied round to deliver a remarkable COVID vaccination programme for young people. This programme is in addition to the programme to deliver first doses, second doses and boosters. As of close of play last night, almost 84,000 doses of vaccine against COVID -19 have been given in Gibraltar since January 2021. Included in this figure are over 4,000 booster doses given to front line health and care staff, people over 50, and clinically vulnerable people. This phase of the vaccination programme will continue until the end of November. The UK government has confirmed that Gibraltar will continue to be supplied with vaccine to complete this phase of the programme in this time-scale".
- 64) The Minister for Health and Care the Hon. Samantha Sacramento said: "A team of over 20 GHA and ERS staff including doctors, nurses, allied health professionals and administrative staff gathered at Westside School at 08:00 on Tuesday morning to set up a temporary vaccination clinic in the school hall. Vaccination commenced at 09:00 and by 09:45 over 100 young people had been vaccinated.
- 65) The plan was to vaccinate over 700 young people by the end of the school day, however, we received a high uptake and thanks to the hard work of our dedicated staff we exceeded our expectations and vaccinated nearly 750 12-15 year olds. I would like to pass on my grateful thanks to everyone involved for their help and support in this programme, which has been a real team effort across health and education, including all the secondary schools in Gibraltar. I would also like to pass on my grateful thanks once

again to the UK government for continuing to supply Gibraltar with this precious vaccine".

- 66) On the 23rd December 2021, The Chief Minister, after an eight months gap, made a **very**, **very**, **very** detailed announcement, in what must arguably be his most patronising, Orwellian-type delivery speech yet. With the new Omicron variant now in the mix, and Xmas approaching, Picardo's subsequent deployment of bland crude statistics attained entirely new levels of absurdity. The complete statement is inserted in Appendix A, as this performance has to be seen to be believed.
- 67) Featured in <u>The Gibraltar Chronicle</u> on 27th December 2021 was the announcement that the Government of Gibraltar hopes to start a public inquiry into Gibraltar's response to the Covid-19 pandemic.
- 68) On 10th January 2022, one year on from Operation Freedom and the Government makes renewed calls for people to take the booster and quotes just one statistic. This was the beginning of the unprecedented Operation Freedom, which to date has successfully administered 108,577 doses of the vaccine to residents and cross-frontier workers.

'A year after the first dose was administered, vaccination remains the best possible means of protection against COVID-19. The virus is spreading quickly through our community and it is important that we keep immunity up through these winter months. Our nurses and administrative staff are working round the clock to make vaccines available to everyone who wants one. Please take up the offer if you haven't already to protect yourself, your loved ones and the GHA.'

- 69) On January 26, 2022, the Gibraltar Social Democrats (GSD) expressed their views on COVID-19 management. Again, they raised concerns about vaccinating children aged 12 to 15, emphasizing the importance of informed decision-making for parents and children. The GSD cited the UK Joint Committee on Vaccination and Immunisation's cautious approach regarding vaccination in this age group.
- 70) In a press statement released on 26th January 2022, entitled Government will continue to be guided by scientific advice 51/2022, ironically its statement ended with the words "Mr. Picardo remains in self isolation as he is currently Covid-19 positive." This raises the question as to whether saline, not the real injections, where given to Picardo, or whether the advice he had been promulgating all along about the vaccines and the booster jabs stemming from science itself, namely Dr. Anthony Fauci, was plain and simply phony baloney right from the start.
- 71) The very last press release issued on-line about Covid-19 came on 23rd April 2022, as some obscure mention was made of a Covid-19 exit strategy. The final message on the pandemic was as follows: "I would encourage people to take up the GHA's offer of the fourth dose of the vaccine to all from the age of 18 and over." Prior to that we were crudely given one last statistic, namely that the total number of Covid-19 related deaths in our community was 102.
- 72) On 30th March 2023, an extraordinary event took place in Gibraltar. It originated from a special interest group, not associated with politics, yet it attracted an audience of over 350 people. It was called "Restorative". Although not officially sanctioned by the government, as they would have had it cancelled, had it not been kept under the radar, this 3-hour gathering brought together experts, witnesses, well-known personalities, and Gibraltarians to consider the "unspeakable." The event aimed to address critical issues and foster dialogue over Covid-19, even if it occurred outside the usual channels. It featured an array of prominent speakers such as Andrew Bridgen MP, Dr. Claire Craig, and Dr. Aseem Malhotra and the film-maker of the documentary Safe and Effective.

- 73) <u>A highlight of the event was Dr. Aseem Malhotra's called upon The Chief Minister and</u> <u>Helen Carter to make a public announcement that there needs to an investigation and</u> <u>suspension of all these Covid mRNA vaccines in Gibraltar.</u>
- 74) The Government first mentioned the notion of having a Covid-19 Inquiry as early as April 2020, and again at the end of 2021. They even mentioned it briefly in response to the Restorative Event in 2023, but events have been overtaken by the McGrail Inquiry. In the UK-Public Inquiry, presided over by Heather Hallet of 7/7 Inquest infamy, incredulously, the remit is fudged and does not specifically delve into the all important subject of examining the evidence associated with the safety of the vaccines. Likewise, Scotland's Public Covid 19 Inquiry overseen by Sidney Brailsford, that too will not directly examine the vaccines for their safety.
- 75) Even in July 2024, official comparative statistical analysis of the local mortality and morbidity experience remains conspicuous by its absence. There does not appear to be any official local studies published of any note, but global data all across the world, when properly analysed in a comparative context, is alarming and cannot be flippantly discarded. In the meantime, until the light is properly shone on what the data actually reveals, we are left with a terrible legacy, as demonstrated in part one by the horribly crude and repetitive statistical babblings of a Chief Minister, still left in power in Gibraltar, who having been at the helm throughout the entirety of the dreadful Covid-19 experience, seems increasingly hell-bent on pushing a globalist narrative, whilst showing wilful blindness, and ruthless criticism towards anything, or anyone, that would dare so much as call into question, the Government's pandemic response.
- 76) In a different sense, the real virus is this: the lies; the damned lies; and the statistics used by evil and crooked politicians, such as Fabian Picardo, in order to coerce the people they govern into submission and towards enslavement and control. In essence, these are the component parts of the real virus, which is sadly spreading like wild-fire on The Rock of Gibraltar. In times of universal deceit, telling the truth becomes a revolutionary act as Orwell had it.
- 77) However, as The Gibraltar Messenger previously stated up-front and from the start, Covid-19 isn't the real virus here. The symptoms of EMF radiation-poisoning are identical to those claimed to be from a virus called Covid-19, and <u>the supposed Covid-19</u> <u>virus, has never been isolated and proven to exist</u>.ⁱ The rollout of the EMF upgrades, coincide with the supposed arrival of Covid-19, and furthermore, the Gibraltar Messenger's article revealed that Coronavirus is traced to the fraudulent British Crown via The Pirbright Institute.ⁱⁱ

78) On 18th June 2024, The Gibraltar Messenger featured an article about a case in The District Court of Thomas County, Kansas, where the Attorney General was suing PFIZER for misleading the public.ⁱⁱⁱ The Gibraltar Messenger posed the question, when will the Gibraltar Attorney General wake-up and do the same? The 179 page complaint, filed against Pfizer can be accessed here.^{iv} The nature of the action is summarised here below.

SUMMARY OF THE NATURE OF THE ACTION AGAINST PFIZER

- 1. **Pfizer** misled the public that it had a "safe and effective" COVID-19 vaccine.
- 2. **Pfizer** said its COVID-19 vaccine was safe even though it knew its COVID-19 vaccine was connected to serious adverse events, including myocarditis and pericarditis, failed pregnancies, and deaths. Pfizer concealed this critical safety information from the public.
- 3. **Pfizer** said its COVID-19 vaccine was effective even though it knew its COVID#19 vaccine waned over time and did not protect against COVID-19 variants. Pfizer concealed this critical effectiveness information from the public.
- 4. **Pfizer** said its COVID-19 vaccine would prevent transmission of COVID-19 even though it knew it never studied the effect of its vaccine on transmission of COVID-19.
- 5. To keep the public from learning the truth, **Pfizer** worked to censor speech on social media that questioned **Pfizer's** claims about its COVID-19 vaccine.
- 6. **Pfizer's** misrepresentations of a "safe and effective" vaccine resulted in record company revenue of approximately \$75 billion from COVID-19 vaccine sales in just two years.
- 7. **Pfizer's** actions and statements relating to its COVID-19 vaccine violated previous consent judgments with the State of Kansas.
- 8. **Pfizer's** actions and statements relating to its COVID-19 vaccine violated the Kansas Consumer Protection Act, K.S.A. 50-623 et seq., regardless of whether any individual consumer ultimately received Pfizer's COVID-19 vaccine.
- 9. **Pfizer** must be held accountable for falsely representing the benefits of its COVID-19 vaccine while concealing and suppressing the truth about its vaccine's safety risks, waning effectiveness, and inability to prevent transmission.

- 79) The same Gibraltar Messenger article covers Dr. Francis Boyle's declaration that Covid injections meet the criteria for biological weapons and weapons of mass destruction. Dr. Boyle is considered one of the world's leading legal experts on biological weapons and he drafted the US Biological Weapons and Antiterrorism Act ("the Act"), which was passed into law in 1989 to implement the Biological Weapons Convention and to criminalise the development, production and possession of biological weapons.^v The interview between Stew Peters and Dr. Francis Boyle discussing the case is highly recommended for viewing in the context of the crime report.^{vi}
- 80) Closer to home, as previously mentioned in paragraph (72), at a non-government sponsored event named Restorative^{vii}, which took place in Gibraltar on 30th March 2023, Dr. Aseem Malhotra, Dr. Clare Craig, and others like Steve Kirsch and Andrew Bridgen delivered presentations related to Covid-19 vaccines. During this extraordinary gathering of 350 people, experts like Dr. Malhotra, a British cardiologist and health campaigner, made the following announcement.^{viii}

"I call upon The Chief Minister and Helen Carter to make a public announcement that there needs to an investigation and suspension of all these Covid mRNA vaccines in Gibraltar."

- 81) This event had provided a platform for open dialogue and truth-telling. Yet despite Dr. Malhotra's public announcement directed towards the Chief Minister and Helen Carter, the experts who had come over to Gibraltar to offer help, were ignored and within a fortnight of the pronouncement, the poisonous deadly booster injections commenced for the over 75's.^{ix}
- 82) Yet, a month before The Rock's Restorative event, in places such as Florida and Arizona, 'Ban The Jab' resolutions, stating that C19 injections are biological weapons, violating the Nuremberg code, came to pass. A ripple effect was starting as can be seen below.
 - a) On 21st February 2023, in Florida, a 'Ban The Jab' Resolution was submitted to the Lee County Republican Party^x, and it passed with 80-90% of the vote. More recently, the Lee County Republican Assembly, which is a grass roots conservative Republican organization, passed Dr. Sansone's resolution declaring the UN, WHO, and WEF, terrorist organizations. The resolution also declares cooperation with these organizations an act of treason against the United States and the State of Florida.
 - b) On 7th March 2023, the **Collier County Republican Party**^{xi} passed the Lee County 'Ban the Jab Resolution'. The resolution got passed with at least 90-95% of the vote.
 - c) On 10th March 2023, lawmakers resurrected two bills targeting COVID-19 'vaccines' in Idaho^{xii}. Senator Ben Adams (R-Nampa) revived last year's 'Coronavirus Pause Act' as the 'Coronavirus Stop Act.' By August 2023, 'Vaccine' Crime Evidence was provided to Idaho Prosecutors and Law Enforcement.
 - d) On 20th May 2023, **The Oregon Republican Party of Clackamas**^{xiii}, called upon Clackamas County to prohibit the sale and distribution of Covid injections and all mRNA injections in Clackamas County and for the County of Clackamas Sheriff to immediately seize all Covid Injections in Clackamas County.
 - e) State Committee official Dan Schultz submitted the 'Ban the Jab' resolution to the **Maricopa County** on 13th 2024 in **Arizona**^{xiv}. It passed with 87.4% of the vote!
 - f) Doctors Alyssa Guglielmo and Andrea Nazarenko got the 'Ban the Jab' resolution passed in Lexington County South Carolina.^{xv} The resolution declared C19 injections biological and technological weapons and calls on the Governor to prohibit their distribution and the Attorney General to confiscate the vials and conduct a forensic...

g) In **Orlando Florida** on Saturday October 14th, NFRA^{xvi} passed an abbreviated version of the 'Ban the Jab' resolution that was added to their platform. The text reads as follows:

"National Federation of Republican Assemblies (NFRA) joins the 'Ban the Jab' movement and takes a stand against biological warfare against American citizens. We call on the states to prohibit the sale and distribution of Covid injections and all mRNA injections as they meet the criteria of biological and technological weapons according to 18 USC 175 Ch. 10, as well as state biological weapons laws, and for the various state Attorney Generals to immediately seize all Covid injections and mRNA injections in their respective states and have a forensic analysis conducted."

- h) The **Hoke County Republican Party in North Carolina** passed the 'Ban The Jab' resolution. It passed on April 10th or 11th.
- i) On 24th September 2023, at their state convention **the Florida Republican Liberty Caucus**^{xvii} passed a policy statement declaring C19 and mRNA injections biological and technical weapons.
- j) The National American Renaissance Movement (National ARM) issued a declaration stating that the UN, WHO, and WEF are terrorist organizations and called for Congress to pass legislation declaring cooperation with these organizations for nefarious purposes an act of treason against the United States and the respective states.
- 83) In October 2022,2) Mislav Kolakusic MEP^{xviii}, in the European Parliament says the Pfizer mRNA Vaccine for Covid-19 does not work, and the European Commission should terminate the contract for more vaccines and hold Pfizer responsible for fake medicine.
- 84) Likewise as a follow-up, Christine Anderson, MEP^{xix}, also exposed the gaslighting and the gigantic lies of Pfizer. Extracts from her brave and insightful standpoint are given below.

Christine Anderson, MEP: "And in the Action Plan, they refer several times to not only Covid-19, but now they slip in influenza. Then of course they go on with the gaslighting and the labelling of 'vaccine hesitancy'. This is what they call it: as 'anti-western' and 'anti-EU'. The vulnerable group among those who should be given priority to take this update vaccine are pregnant women. We are pleased to hold another press conference today because of the events unfolding after the committee session last Monday, when our colleagues asked Pfizer a question. And the answer is what made the used the news. To put it in a nutshell. The cat is out of the bag. It was a gigantic lie what they told us. That these vaccines would prevent you catching this virus and prevent transmission."

"Well none of that was true as it turned out, and based on that lie, all of those mandates, all of the lockdowns, all of the non-pharmaceutical measures of wearing masks, staying at home, curfews and all that was based on that gigantic lie. And yet they will not acknowledge it. No, they just go ahead and do whatever they want to do with us. I would like to point out a couple of things from the EU Commissions Action Plan -EU response to COVID-19 in preparing for autumn/winter 2023. As you might have guessed of course the focus is still on these hazardous mRNA injections. Well, that's not surprising here. They would like to implement and coordinate effective communication initiative and strategies to promote uptake of additional injections and complete the primary series of those who have not even begun yet. **The unvaccinated.**"

Christine Anderson continued.

"So once again, a particular group of the population is being targetted and yes, well, that's what they are trying to do. They would like to increase vaccine confidence by debunking misinformation and disinformation. Well who is spreading the **mis-and-the-dis-information**? It is the EU Commission; it is the pharmaceutical companies; it is government, especially in the western democracies. They are the ones spreading the **mis-and-the-dis-information**. They are the ones telling people lies. For what? So that the pharmaceutical companies make profit, and profit. And the risks? Well guess what? You, the taxpayers, you will be left with the risks."

"And then of course, they want to target hard-to-reach population groups. Well I guess in that instance they are talking about me. Yes, I'm in a hard to reach population group because I saw through their lies from the get-go. I'm still unvaccinated, and I will remain unvaccinated, and I will not inject a poisonous substance into my body. Point blank. So go ahead and try to target me. Good luck with that."

85) In 2023, with the so-called Pandemic behind Europe, French MEP Virginie Joron^{xx} in the European Parliament, followed in the footsteps of brave Christine Anderson, and she too gave a memorably powerful and insightful speech in outright condemnation of the secret Pfizer deals which had been agreed behind closed doors. Here below is the English translation of the brave French lady's speech, calling out her fellow politicians who had sold out:

Virginie Joron Continued:

"You congratulate yourselves, you want to flood Europe and Africa with vaccines, when they don't want them. You want to introduce a European Vaccination schedule to educate us about vaccination, to reintroduce the QR code. You fight against those who do not agree with you. This report is a reflection of whom? Of what? Of what work? Of which lobby? The only winner is Pfizer. You have forgotten the European taxpayers, but I'm sure they will not forget this in the next elections. 86) With further reference to Ursula von der Leyen above, an Expose-News report dated 18th July 2024, and brought to your attention by the Gibraltar Messenger, not HMGoG revealed that the European Court of Justice ruled that the European Commission was wrong to conceal details of its multi-billion euro deals for the covid vaccines. The Court stated that Pfizer is liable for damages if its covid vaccine is defective. The President of The European Commission was already under scrutiny for allegedly keeping secret and deleting text messages with Pfizer CEO Albert Bourla over vaccine purchases in a controversy dubbed "Deletegate".

Are Pfizer's Covid Injections Defective?

- 87) The European Court of Justice referred to Directive 85/374 to rule that "a producer is liable for the damage caused by a defect in its product." The Directive defines "producer "as "the manufacturer of a finished product, the producer of any raw material or the manufacturer of a component part and any person who, by putting his name, trade mark or other distinguishing feature on the product presents himself as its producer" as well as any person who imports a product for sale or any form of distribution in the European Community in the course of his business (Article 3).
- 88) The definition of damage includes "damage caused by death or by personal injuries" (Article 9). The covid vaccines have caused death and personal injury. So, are they defective? The public has been told continuously and repeatedly for more than 3.5 years that the covid vaccines are "safe and effective," albeit varying degrees of effectiveness as time progressed. Here's what the Directive states about a defective product:

"... to protect the physical well-being and property of the consumer, the defectiveness of the product should be determined by reference not to its fitness for use but to the lack of the safety which the public at large is entitled to expect; whereas the safety is assessed by excluding any misuse of the product not reasonable under the circumstances. [Emphasis added]"

89) The covid vaccines lack the safety that the public is entitled to expect. It would seem that according to the European Court of Justice's ruling on Wednesday, Pfizer's covid product is defective and Pfizer is liable for the deaths and injuries it has caused.

- 90) Returning to what happened on The Rock, on 17th March 2021, Fabian Picardo in his own self-congratulations, said this: *"The United Kingdom has played a blinder and we are among the beneficiaries in the British Family of Nations."* The hapless and discredited Matthew Hancock in congratulating Gibraltar, addressed The House of Commons, the next day like so, with the following short speech. ^{xxii}
- 91) The "deal" had helped accelerate the production and distribution of Covid-19 vaccines. Officials failed to disclose to their constituents that the COVID-19 (mRNA) vaccines were/are experimental. The COVID-19 vaccine phase 3 clinical trials have not yet been completed and are authorized under emergency use only. The long-term risks are unknown. The short-term risk of harm from the vaccine is far greater than the risk of dying from COVID-19. Lack of evidence that the vaccine will, in fact, prevent infection, is not Pfizer's concern, sales and profits are – and this means a high vaccination rate – which became the designated focus of officials in Gibraltar, as they kept up their part of the bargain.
- 92) At this point, it should be noted that in France, it has been has ruled that death arising from an injection against covid, to be suicide. The judge took the side of the insurance company, which refused to pay insurance to the children of a millionaire who died after being vaccinated.^{xxiii} The family sued the insurance company, but lost. The judge ruled that the side effects of the experimental vaccine were made public and the deceased could not claim to be unaware of them when he voluntarily took the vaccine. The court also stressed that in France there is no law that forced him to be vaccinated.
- 93) "Therefore, his death, in fact, is a suicide," the court ruled.

Legal Action Taken Against Pfizer

- 94) During the last year, five US states have separately taken legal action against Pfizer regarding COVID-19 vaccine safety. The five states are Texas, Utah, Kansas, Mississippi, and Louisiana.
 - a) On 30th November 2023, the Gibraltar Messenger website highlighted the fact that (a) Texas Attorney General Ken Paxton has taken legal action against Pfizer^{xxiv} alleging that the pharmaceutical company unlawfully misrepresented the effectiveness of its COVID-19 vaccine and attempted to censor public discussion about the product. Paxton's lawsuit claims that Pfizer engaged in false, deceptive, and misleading acts by making unsupported claims regarding the vaccine's efficacy, violating the Texas Deceptive Trade Practices Act. The company's widespread representation of 95% efficacy was based on a calculation of "relative risk reduction" during its initial clinical trial, which FDA publications deem misleading.
 - b) Additionally, Pfizer allegedly withheld information about the vaccine's duration of protection and failed to measure its effectiveness against transmission. When the vaccine's shortcomings became apparent, Pfizer allegedly attempted to silence truth-tellers. The lawsuit aims to seek justice for Texans who were misled and harmed by Pfizer's action. You can find more details about this case in the official press release^{xxy}. The lawsuits claim that Pfizer misled the public by marketing its COVID-19 vaccine as "safe and effective."
 - c) As previously mentioned, on 18th June 2024, The Gibraltar Messenger website highlighted the fact that Kansas Attorney General Kris Kobachi is also suing pharmaceutical giant Pfizer for misleading Kansas residents about the safety and efficacy of its COVID-19 vaccine.^{xxvi} Kansas has filed a lawsuit against Pfizer Inc., alleging that the pharmaceutical giant misrepresented the safety of its Covid-19 vaccine and violated the state's consumer protection law. The lawsuit, filed by state Attorney General Kris Kobach in Kansas District Court, Thomas County, accuses Pfizer of

misleading the public by claiming it had a safe and effective Covid-19 vaccine. However, Pfizer allegedly never studied the vaccine's effect on virus transmission. The state seeks damages for Pfizer's violations of the Kansas Consumer Protection Act and asks the court to order civil penalties for alleged violations of previous consent orders with the state. Pfizer, in response, maintains that its representations about the vaccine have been accurate and science-based.

- d) The State of Louisiana also claim that Pfizer concealed information about vaccine risks, including myocarditis, pericarditis, failed pregnancies, and deaths. A lawsuit by Covid-19 vaccine recipients claiming they were injured by their shots may usher in long-awaited changes to how the federal government handles immunization injuries.^{xxvii} For years, attorneys and activists representing Americans injured by routine vaccinations have been pushing lawmakers to reform how the HHS reviews requests for compensation. They say that the process, dubbed the Vaccine Injury Compensation Program, is in desperate need for more special masters to review the backlog of nearly 4,000 injury claims.
- e) The Mississippi lawsuit alleges that Pfizer urged Americans to get vaccinated, claiming that the vaccine stopped transmission. The lawsuit alleges that Pfizer concealed evidence related to severe myocarditis (inflammation of the heart) and pericarditis (inflammation around the heart).
- f) Independent presidential candidate Robert F. Kennedy Jr. has backed all five lawsuits and he has been vocal in criticizing Pfizer over its Covid-19 vaccine. Kennedy Jr. took to social media to highlight the legal action, emphasizing that multiple states—Texas, Utah, Kansas, Mississippi, and Louisiana—are now suing Pfizer. The tide appears to be turning in favour of the states.
- 95) In Northern Ireland, during a recent event at Stormont^{xxviii}, concerns were raised about individuals who consider themselves "vaccine injured" feeling marginalized. These individuals believe their experiences are often misunderstood, misrepresented, or used for other agendas. The discussion highlighted the need for empathy and scientific follow-up regarding vaccine side effects and injuries.
- 96) In Thailand, even the mainstream media there, are warning about Covid vaccines. Long Covid-19 infections and multiple Covid-19 vaccinations might let hidden diseases surface, weaken immunity and lead to cancer and brain disorders, according to authorities from Chulalongkorn and Rangsit universities. They cause cancer and brain tumours.^{xxix}
- 97) The Gibraltar Messenger has highlighted the situation in the United Kingdom, and the message is that if members of parliaments/congresses followed in the footsteps of Andrew Bridgen MP^{xxx}, they might prove their worth to those who voted for them. Instead, they obstinately continue to head in lockstep together, following a roadmap designed by unelected puppeteers who pull their strings and provide their purse. Money Talks with his motto "Controlled by nobody. Representing everybody", Independent Member of Parliament for North West Leicestershire, Andrew Bridgen did the following:
 - a) called for debates on excess deaths in the UK Parliament;
 - b) accused the Medicines and Healthcare products Regulatory Agency (MHRA) of criminal conduct concerning approval of the mRNA injections;
 - c) recognizes the Midazolam murders;
 - d) warns us about the World Health Organization's power-grab;
 - e) accused Prime Minister Rishi Sunak of treason;
 - f) and calls for the return of CAPITAL PUNISHMENT.

Pfizer and The Secret Contracts

98) With Israel, a nation that was rivalling Gibraltar, in terms of its speed of the roll-out of their Pfizer inoculation programme to their population, ethical concerns were soon raised about decisions to trade Pfizer doses for medical data amidst possible privacy violations and a deepening of the global vaccine divide. Prime Minister Benjamin Netanyahu^{xxxi} – who was stumping as Israel's vaccinator-in-chief ahead of the country's March elections back in March 2021, said that he reached the deal with Pfizer's chief executive to speed up vaccine deliveries to Israel.

"Israel will be a global model state," he said. "Israel will share with Pfizer and with the entire world the statistical data that will help develop strategies for defeating the coronavirus."

- 99) Israel played a significant role in Pfizer's Covid-19 vaccine rollout. In exchange for being the first country to administer the vaccine to its population, Israel entered into two agreements with Pfizer^{xxxii}. One of these agreements, known as "The Real World Epidemiological Evidence Collaboration Agreement," allowed Pfizer to conduct a real-world study of its vaccine efficacy using the Israeli population as test subjects (in other words guinea-pigs). However, it's important to note that the research outcome measures defined in this agreement did not include safety considerations^{xxxiii}. Additionally, Israel also signed additional agreements with Pfizer for the supply of millions of vaccine doses in 2022/23.
- 100) In an article excerpt about Pfizer and Israel, of which the same can be said about Gibraltar, demand for the vaccines has been generated by the continuous scaremongering propaganda which fomented a heightened degree of fear and panic. Public health officials DISCARDED the precautionary principle in medicine – "First, do no harm" – and despite serious uncertainty, officials proceeded full speed ahead, with mass inoculation.
- 101) Meanwhile, Pfizer reserves the right to silence governments; Pfizer controls donations; Pfizer secured an "IP Waiver" for Itself; Private arbitrators, not Public Courts, decide disputes in secret. Pfizer can and Pfizer does go after state assets and Pfizer calls the shots on key decisions.
- 102) In Johannesburg, South Africa Big pharmaceutical companies "bullied" South Africa into signing unfair agreements that forced the country to overpay for COVID-19 vaccines compared with Western nations^{xxxiv}, according to a non-profit that lobbied for the details to be released. The details were revealed in an analysis by the Health Justice Initiative (HJI), a South African NGO campaigning against public health inequality after it won a court bid last month to get the government to release its contracts. During the height of the pandemic, Johnson & Johnson (J&J) charged South Africa 15 percent more per dose of its COVID vaccine than it charged the European Union, while Pfizer-BioNTech charged South Africa nearly 33 percent more than it reportedly charged the African Union, according to vaccine contracts between the pharmaceutical companies and the government.
- 103) Latin American countries have also faced significant challenges in their COVID-19 vaccination efforts, particularly with Pfizer.^{xxxv} Here's what you need to know:
 - a) During COVID-19 vaccine negotiations, Argentina and Brazil did not sign vaccine supply deals with Pfizer due to the company's demands. Pfizer reportedly asked these countries to put up sovereign assets, including military bases and federal bank reserves, as collateral for potential future legal costs. Additionally, an unnamed Latin American country eventually reached an agreement with Pfizer, but with a three-month delay, affecting its ability to address the COVID-19 crisis promptly.

- b) Pfizer faced accusations of "bullying" during negotiations with Latin American governments. The company reportedly asked some countries to put up sovereign assets (like embassy buildings or military bases) as collateral for vaccine payments. Brazil and Mexico, for instance, contracted for Pfizer-BioNTech and Oxford-AstraZeneca vaccines but faced delays in delivery.^{xxxvi}
- 104) In England, there is a brave former police officer named Mark Sexton. He was first brought to the attention of the Commissioner of the Royal Gibraltar Police on 7th July 2021, as he was featured prominently in the report 'Policing The Corona State' as documented on The Gibraltar Messenger Website.^{xxxvii}
- 105) Mark Sexton has often made a clarion call for police to their job, and has filed crime reports about the Pfizer fraud to The Metropolitan Police. Speaking on 2 February 2024, he made an important video on the contract that Pfizer signed with the South African Government in relation to the Covid-19 vaccines. The South African Supreme Court ordered the South African Government to release the contract for the public to scrutinize. The Gibraltar Messenger covered this subject and contextualised it given Gibraltar's contractual arrangement with the UK, over the purchase of Pfizer's poisonous bioweapons.^{xxxviii}

9th Circuit Court Rules COVID-19 mRNA Injections Are Not Legally Vaccines

- 106) As previously referred to, the important judgement of the 9th Circuit Court of Appeals, one level below US Supreme Court, it was decided that the Covid mRNA jabs are NOT vaccines. This removes the drug companies' immunity and renders the authorisations for them illegal. It also makes it a crime for medical professionals to call them vaccines any longer. HEALTH FREEDOM DEFENSE FUND, INC. V. ALBERTO CARVALHO, No. 22-55908 (9th Cir. 2024)^{xxxix}
- 107) Also, as previously relayed to the RGP Commissioner. In Appellate Court by The Professor who wrote the 1989 International Bio-Weapons Law. He has declared the jabs a biological weapon. If agreed by the court and the Grand Jury mentioned in the article below, this means all those involved in manufacturing, distributing, promoting mandating and administering the Covid 19 mRNA jab are guilty of many crimes, including Crimes against Humanity, Domestic Terrorism, Bio-Terrorism and multiple breaches of the Nuremberg Code, where "I did not know", or "I was only following orders", did not suffice as excuses. - 110) Recent articles include the following.

Pfizer's Whistleblowers Stepping-Up to the plate

- 111) Throughout the Covid-19 era, and continuing to the present day, at least four high profile and extremely credible whistleblowers have exposed the giant Big Pharma company, and given their expert inside knowledge. They should be taken deadly seriously. Their names, together with some on-line insight on their respective backgrounds, are itemised as follows:
 - a) **Frank Han**, a former director of global compliance analytics at Pfizer, filed a civil complaint against the drug-maker in California. He claims he was terminated for identifying potential Foreign Corrupt Practices Act (FCPA) issues within the company. Han discovered that Pfizer had spent significantly more money on potentially influential government officials (PIGOs) in China than in other countries. Despite bringing this data to his supervisors, he saw no evidence of a company investigation. Han was ultimately fired in November 20221.^{xliii}
 - b) **Brook Jackson**, a regional director at a contract research organization called Ventavia, blew the whistle on Pfizer's pivotal phase III trial for the COVID-19 vaccine. She reported falsified data, unblinded patients, inadequately trained vaccinators, and slow follow-up on adverse events. Jackson's revelations raised concerns about data integrity and misconduct in vaccine trials.^{xliv}
 - c) Melissa McAtee, a former Pfizer employee, gained attention in October 2021 when she leaked company emails alleging the use of human fetal tissue-derived cell lines in mRNA vaccine laboratory tests1. These leaked emails included correspondence from Vanessa Gelman, Pfizer's senior director, advising colleagues to avoid discussing the topic of fetal cell lines1. She recently released a video addressing fears about her own safety and wellbeing, emphasizing that she is not suicidal and remains committed to raising awareness about mRNA vaccines.^{xlv}
 - **d)** Becky McClain, a federal jury has awarded \$1.37 million in damages to a former Pfizer scientist and whistleblower, who claimed she was sickened by a genetically engineered virus at a company laboratory and then fired for raising safety concerns.^{xlvi}

 - c) Since 2004, Pfizer has settled three of the largest healthcare fraud cases in the history of the United States. These three cases alone which includes the Pfizer whistleblower case above have returned roughly \$3.51 billion (which includes a \$1.3 billion criminal fine as part of a landmark 2009 settlement) to the government.^{lix}
 - d) In **2009**, thanks to the work of six whistleblowers, Pfizer, the inventor of Viagra, were fined \$2.3 billion for illegal marketing in off-label drug case.^{lx}
 - e) Pfizer was forced to pay compensation to families of children killed in the controversial Trovan drug trial. During the worst meningitis epidemic seen in Africa, in **1996**, Pfizer ran a trial in Nigeria of their new drug Trovan.^{1xi} Five of the 100 children who took Trovan died and it caused liver damage, while it caused lifelong disabilities in those who survived. But another group of 100 children were given the conventional "gold standard" meningitis antibiotic as a "control" group for

comparison. Six of them also tragically died because, the families said, Pfizer had given them less than the recommended level of the conventional antibiotic in order to make Trovan look more effective.^{$|x_i|$}

- f) 2007: Pfizer 'used dirty tricks to avoid clinical trial payout' Eleven Nigerian children died, and others suffered disabling injuries including deafness, muteness, paralysis, brain damage, loss of sight, slurred speech. Pharmaceutical giant Pfizer hired investigators to find evidence of corruption against the Nigerian attorney general to pressure him to drop a \$6 billion lawsuit over fraudulent drug tests on Nigerian children. Researchers did not obtain signed consent forms, and medical personnel said Pfizer did not tell parents their children were getting the experimental drug. The details of the case were first exposed in 2000 in an investigative series in the Washington Post. In 2007, Nigerian officials brought criminal and civil charges against Pfizer in a multi-billion-dollar lawsuit.
- g) 2012: Pfizer had to pay around \$1billion to settle lawsuits claiming its Prempro drug caused breast cancer. Prempro was used in hormone replacement therapy, usually for women going through the menopause.^{1xiii} The settlements came after six years of trials and hardship for the women affected.^{1xiv}
- h) **2013:**Pfizer <u>paid out \$273 million</u> to settle over 2,000 cases in the US that accused its smoking treatment drug Chantix of provoking suicidal and homicidal thoughts, self harm and severe psychological disorders.^{lxv}
- Pfizer was also accused of improperly excluding patients with a history of depression or other mental disturbances from trials for the drug. Later, in 2017, a coroner in Australia ruled that the drug had contributed to a man's suicide. The man's mother campaigned to change the label on the drug.^{lxvi}
- j) 2020: Pfizer reached an agreement with thousands of customers of its depotestosterone drug in 2018 after they sued it for increasing the likelihood of numerous issues, including heart attacks.^{lxvii}
- 115) Long before Pfizer became the mRNA "vaccines" of choice for Gibraltar, due diligence and exploratory data analysis would have revealed that Gibraltar was in the process of placing its trust for the lives of its population into the hands of a giant Big Pharma company, with an absolutely atrocious toxic reputation. Pfizer is nothing short of a highly organised crime group, with a litany of serious cases of fraud and a portfolio of health-harming medical criminal practices all undertaken with nefarious intent.
- 116) So having made the injections designed to cause the cancers, at great profit, Pfizer is completing the hegelian dialectic cycle, by significantly expanding its efforts in cancer treatment. They recently acquired Seagen^{kviii}, a leading developer of antibody-drug conjugates (ADCs), for \$43 billion. Their focus includes treatments for breast cancer, genitourinary cancers, haematological malignancies, and thoracic tumours. These are all symptoms of the the jabs that they manufactured. This expansion is part of Pfizer's broader strategy to enhance its oncology portfolio and deliver innovative cancer therapies globally.
- 117) Part 3 of this report will follow shortly. It will delve into the excess deaths experience, but to finish off part two of this report, and answer to the question posed at the start of this section, namely, how do you solve a problem like Pfizer and Big Pharma? For people on The Rock of His Defence, the answer is straightforward. It is to get tiny Gibraltar to do the right thing and have Fabian Picardo arrested and investigated for crimes against humanity, and help us set aside the evil from our midst, exactly as you were previously asked to do, three years ago to the day.

- 119) In the aftermath of the Covid-19 inoculation and booster roll-outs, part 3 of the crime report will primarily serve to illustrate how alarming patterns of excess deaths are occurring across many of the nations of the world, amidst a backdrop of deafening silence from most of our world leaders. This section will consist of a statistical digest section, showing some shocking worldwide mortality statistics in a comparative context.
- 120) Save for a rare breed of awakened exceptional individuals in the political arena, namely Robert F. Kennedy Jnr. in America, Andrew Bridgen in Britain, and Christine Anderson in the European Parliament, the number of political leaders who sheepishly remain silent, and prefer to show their allegiance to their global elite puppet masters, represents a threat to humanity like never before. The puppet masters of these politicians are the unelected world leaders from the usual acronym gang of suspects, namely WHO, WEF, and UN, alongside certain key individuals like Bill Gates, Anthony Fauci, and Yuval Noah Harari to name just a few. With all these bought and paid for people, there is nothing but deathly silence. Here on the Rock, our politicians have rendered themselves complicit in the very evil they have failed to oppose. Our politicians stand accused of being willing participants in a joint criminal enterprise cult akin to death by government, democide in Gibraltar.
- 121) Hardly anybody dares to talk openly about these stark patterns which emerge from the backdrop of the Covidian era. The statical data is too ugly to look at and so cognitive dissonance prevails for the most part. Yet the patterns in the data are nevertheless there to see, hidden in plain sight, but only for those brave enough, to <u>not</u> want to show wilful blindness to the mass murdering in our midst. To dare to discuss such things publicly has been rendered off-limits by the controlling elite, as to have it otherwise, would indict them all and risk jolting the masses away from their comfort zones and deep-state slumber. Yet, as Muad'Dib would have it: "The Sleepers Must Awaken".^{lxix}
- 122) Picardo made no attempts to awaken the people to the serious problems with the injections he had coercively promoted. He kept quiet when AstraZeneca's jabs got withdrawn globally after the company admitted the jabs could cause adverse side effects. On 30 April 2024, AstraZeneca conceded the vaccine, can cause fatal blood clots and low platelet counts, also known as thrombosis with thrombocytopenia syndrome, or TTS. The admission came through court documents in a UK class action lawsuit which sought £100m in compensation for almost 50 victims of AstraZeneca vaccine side effects.

123) In Australia, Health Minister Mark Butler said: "AstraZeneca took a decision to withdraw its first generation COVID vaccine quite some time ago, so it hasn't been available here in Australia for a considerable period of time, and that's no surprise really."

"It was the first generation vaccine and has been superseded by a range of newer vaccines that particularly targeted the newer variants."

- 124) Neither has Picardo made any attempts to inform Gibraltarians that four Scandinavian countries namely Sweden, Norway, Finland and Iceland, had previously taken steps to limit or pause on the use of the Moderna injection, particularly for younger age groups. This was due to concerns about rare side effects like myocarditis and pericarditis.^{bxx} Likewise Picardo has kept quiet about the European Union, where much controversy surrounds President Ursula Von Der Leyen's communications with Albert Bourla, The Chief Executive Officer of Pfizer, over redacted contracts. Is that because contractual arrangements for Gibraltar, and UK are likewise heavily redacted?^{bxi} With the Pfizer mRNA injections, a deathly hush has pervaded the corridors of power of most of the world's governments, who have acted in lockstep with the Rockefeller Foundation, and where in 2020/21, all almost without exception, by deceptive and coercive means, pushed poisonous injections and booster shots onto their adults and children for Big Pharma profit.
- 125) The primary source of this excess mortality data is the Human Mortality Database (2024); World Mortality Dataset (2024); Karlinsky and Kobak (2021) processed by Our World in Data. Seeing is believing, and so what follows in the first instance is a visual series of 30 statistical charts showing excess mortality rates, grouped by nations across the world. Complementary statistical data extracted from Ed Dowd's book 'Cause Unknown'^{txxii} is also utilised in part. Contrary to all his previous historical paragon of virtue utterances at the onset of the pandemic, these statistics are the very things that our current Chief Minister, will always want to keep hidden from Gibraltarians because they serve as an indictment upon him.
- 126) Using UN data from the "Our World Data" resource, in the vast majority of excess deaths for all cause mortality, it's not easy to find a country that did experience a predominance of excess mortality rates in the immediate time periods following the Big Pharma vaccine roll-out. Furthermore, Gibraltar, whose government, basked in the glory of being the first country to inoculate its entire population, appears in one sense to be an exception to this rule. It appears that HMGoG saw fit to keep mortality data hidden from all public gaze and scrutiny, as evidenced in the missing data within the "Our World in Data" resource. Conspicuous by its absence in this analysis therefore is Gibraltar's very own experience, in the immediate aftermath of the huge spike in deaths during Gibraltar's saddest month (January 2021), where official mortality statistics in a comparative context have been suppressed from public viewing, and neither government, nor opposition parties, nor lawyers, nor Gibraltar Health Authority, nor the police, nor any of our mainstream media outlets, have lifted a finger to rectify that unacceptable state of affairs.
- 127) What follow is an important statistical digest with a focus on excess deaths. It may be seen by some as a plethora of deeply disturbing home truths in the form of a relatively easy to understand statistical digest, yet, sadly for many, the consequences of being exposed to it, will be far too unsettling for the people of The Rock to contemplate the harsh reality of the situation.
- 128) In addition to this, two short but visually impactful slide-shows have been placed on The Gibraltar Messenger website for further edification purposes.
 - One is based on a tiny glimpse of the work of Ed Dowd who has written a recommended book titled "<u>Cause Unknown: The Epidemic of Sudden Deaths in 2021 & 2022</u>,"^{lxxiii} where he examines the rise of sudden deaths among young, healthy people during that period.

Dowd noticed an increase in news anecdotes about sudden deaths among fit athletes and seemingly healthy young people across various countries. His thesis was that the mass vaccination campaign for COVID-19 in 2021 played a role in these deaths. Throughout his career, Dowd utilized pattern recognition to stay ahead of his peers in stock picking.

- 129) To coin a phrase from Edgar Hoover would seem especially apt in these daunting circumstances:



GROUP 1: A Selection of Excess Deaths Rates from Various Familiar Countries



Alarmingly, all six countries shown above have experienced a near permanent state of excess deaths ever since the vaccine roll-out commenced. This is denoted by the time-series plot, as shown within the segment of the chart positioned to the right-hand-side of the vertical dotted red-line, and lying above the horizontal axis (denoted as 0%). The vertical dotted red-line indicates the time when "vaccine" roll-out commenced. A feature of five of the six charts, is the fact that prior to the vaccine roll-out, excess deaths were not the norm. The respective line-graphs often dipped below the horizontal access, whereas after the vaccine roll-out, the line-graph remain mostly above the axis, often on a disconcertingly high scale. 


GROUP 2: A Selection of Excess Deaths Rates from Various Familiar Countries in Britain and Europe




In this next group of six-charts, it is the eye-catching Gibraltar chart which stands apart because of its truncated missing data. This follows the huge spike in excess deaths in January 2021. That series anomaly apart, once again all other five countries show the same recurring pattern of excess deaths once the "vaccine" roll-out commenced. While the line-graphs can be seen to occasionally dip underneath the horizontal axis, more often than not, the time-series plot remains above the horizontal axis, with several noticeable spikes patterns occurring throughout. 




Yet again, all above charts from group 3, show excess deaths occurring after the mass vaccination programme commenced – a familiarly recurring pattern which was far less evident prior to the start of the roll-out of the injections. It can be seen that on five of the six charts, data for two countries has been shown. Germany has been paired with Austria, Sweden has been paired with Denmark, and Belgium with the Netherlands in order to show the remarkable similarity of the trends of these neighbouring paired countries. Surprisingly, Slovenia and Slovakia as a pairing show almost identical line graph trends, even though the two countries do not share a border. The Greece and Turkey pairing also shows line graphs showing similar patterns of peaks and troughs. 







From charts in this group, it can be seen that the excess death rate experience is on an altogether much higher scale than other groups displayed previously, as can be seen by noting the much wider range of the Y-axis. Suffice to say, the recurring pattern of excess death rates, in the immediate aftermath of the vaccine roll-out, compared with before it, is not only evident, but extra-ordinarily pronounced in all six illustrations. GROUP 5: A Selection of Excess Deaths Rates from North Africa and The Middle-East




From the charts shown, it can be seen that the almost identical recurring pattern of high excess death experience, again occurs in the immediate aftermath of the initial vaccine roll-outs. Such patterns are now becoming very difficult to keep from those with the inclination to examine more closely. It is abundantly clear that these patterns are not isolated events. The patterns are indicative of a systematic process which is leading to population reduction. When viewed collectively, it can be seen that such patterns are consistent with the stated intentions of certain prominent globalists such as eugenicist Bill Gates, and Klaus Schwab of The World Economic forum, who is a technocrat and promoter of transhumanism.


Excess mortality: Deaths from all causes compared to projection based on previous years, by age

INFERENCE

Fabian Picardo, as Chief Minister of HMGoG, has played a tiny role in one of biggest acts of coordinated medical tyranny ever unleashed upon the world at large. His crime is to have coerced Gibraltarians, by deceptive means, to be the guinea pigs of the first territory/nation to take-up a poisonous bioweapon from Pfizer in support of a treasonous long-term globalist plan to depopulate and control the world, while facilitating 5G Electro Magnetic Frequency Technology throughout Gibraltar. In so doing, Fabian Picardo has considerably shortened the life-expectancy of almost all of those unsuspecting Gibraltarians, who fell for his fear-mongering trick, and who were persuaded to take the medical poison which is now causing not only a huge number of excess deaths, but also an increasing array of health issues, from cancers, to blood clots, in most countries across the world. Fabian Picardo is playing a major role, in hiding from the public the number of deaths and the extent of the adverse reactions from his evil JABS-TO-GIB democide initiative on The Rock.

PREMISES

- By 12th February 2020, HMGoG had published details of Regulations under the unlawful Civil Contingencies Act to Protect against Coronavirus – 78/2020.ⁱ This signified that the government of Gibraltar, led by Fabian Picardo, was positioning itself to be in full lockstep with the globalists' agenda, as outlined in a desktop exercise in 2019, known as Event 201.
- 2. After months of fluctuating and irrational lockdown measures for the rest of 2020, all of which were in lockstep, with the Globalist's agenda, The Chief Minister misled the public that Gibraltar had purchased a "safe and effective" COVID-19 Pfizer vaccine from the UK. The UK purchasing agreement was heavily redacted, disguising the fact that the long termeffects of the vaccines were not known. Picardo unwittingly or otherwise unleashed on the largely unsuspecting men, women, and children of Gibraltar, a poisonous bioweapon designed specifically for population reduction and control. Given most of the population accepted the jab in mindless obedience to the government, untold damage to the population's health has been done.
- 3. The people on the Rock were brainwashed into believing that the vaccines would save countless lives, yet no proof was on offer. The public were not told that the statistical models used to justify such claims derived from Neil Ferguson whose previous statistical models from Imperial College had been widely off the mark.
- 4. No sooner than when the Pfizer injection roll-out started on 10th January 2021, an unprecedented outbreak of deaths, all attributed to Covid-19, occurred in the Elderly Residential Homes. The public were told by the Director of Public Health that there was no evidence that any of these deaths were from the vaccines. However, the cause of many of these deaths were not subjected to Coroner's reports and precisely what happened in Gibraltar's saddest month, has never been subjected to any kind of independent scrutiny. Meanwhile patterns in the timing of vaccine roll-outs correlating with spikes in excess deaths are being ignored. Previous promises from The Chief Minister concerned with openness and transparency have demonstrably proven to have been lies.
- 5. Over time, the Chief Minister never stopped claiming the COVID-19 vaccine was life saving and effective. Well-documented intelligence suggests that the government and politicians knew that the vaccines were causing harmful effects and death, yet when in March 2023, Dr Aseem Malhotra called for a cessation of the mRNA vaccines there was a deathly silence from the government and the GHA.

- 6. Government promises of an Independent Covid Inquiry have yet to materialise, but in the meantime, the government pushed through controversial unlawful legislation known as the Inquiries Act.
- 7. The Chief Minister peeled off his shirt and allowed himself to be inoculated before a camera in November 2021. In a similar vein, to his counterpart Boris Johnson in the UK, Fabian Picardo had tested positive for Covid in October 2021. Intelligence suggests he was given a saline solution. The same intelligence further suggests that other politicians who likewise took the jab, and posed for the camera, most notably Samantha Sacramento, were likewise given the placebo versions. Fabian also saw fit to pose for the camera to supposedly lead the charge for the booster campaign and used social media in efforts the maximise the take-up of the poisonous injections.
- 8. Throughout this period, in stark contrast to all the earlier promises, there has been a dearth of local data on mortality or morbidity statistics. No government official has been heard publicly to utter any reservations about the vaccines.
- 9. To keep the public from learning the truth, Fabian Picardo went to extraordinary lengths to indirectly censor speech on social media and besmirch those questioning the official narrative. From scanning the horizons, The Gibraltar Messenger website and the Defending Gibraltar forum, both offered-up regular extremely insightful articles as to what was really going on all across the world in response to these Covid-19 measures. The volume of insightful articles grows exponentially. Other forums such as Freedom Gibraltar also helped ensure that those interested groups awakened to wider developments across the world, had a valuable intelligence resource and a support network. Periodically, links to key articles from the Gibraltar Messenger on the insight on offer were sent direct to the local politicians and the police. Sadly, no politician ever saw fit to respond in a meaningful manner and Fabian Picardo warned the public against anything that was not sanctioned by government. On all things Covid, members of Fabian Picardo's party all became subservient to an official narrative that over time grew increasingly more absurd. When the opposition expressed reservations about injecting the young in the Autumn of 2021, Picardo treated the legitimate concerns disdainfully, scoffing at the GSD, accusing them of pandering to the anti-vax lobby.
- 10. This year saw the evidential hearings take place for the McGrail Inquiry where, thanks to the coverage of the GBC, the people of Gibraltar could witness proceedings live. Fabian Picardo gave evidence for two full days before Peter Openshaw, and without straying into the business of the commissioner who is preparing his report, it was noted with extra special interest that Fabian Picardo at one point saw fit to quote from comments made by former Labour Party MP Andy Burnham. Those comments cited from Andy Burnham, were referring to the importance of truth telling in relation to the UK Blood Contamination Scandal. The irony is that the comments recited by Fabian, where even more applicable to the need for truth telling, as to how people's blood has been contaminated via the jabs of Big Pharma.
- 11. From arm-jabbing to backstabbing, poignantly, in a farewell speech to the former governor David Steel, who lent his support to Operation Freedom, Fabian Picardo saw fit to characterise their relationship akin to Cassius and Brutus, the two most prominent men who plotted and participated in the treasonous back-stabbing murder of Julius Caesar. The similarities with how Fabian and Sir David plotted and participated in the treasonous armjabbing murder of the sleep-walking and unsuspecting Gibraltarians were not lost on the author of this report.
- 12. Picardo must be held accountable for falsely representing the benefits of the COVID-19 vaccine while concealing and suppressing the truth about the vaccine's safety risks, waning effectiveness, and its inability to prevent transmission.

13. While it is not known to the general public exactly how financially well-off Fabian Picardo is, it came to light recently in the McGrail Inquiry that Fabian Picardo considers himself to be wealthy.

"I'm in my early 50s, through Hassans and not through Hassans, I have minor stakes in businesses. I am wealthier than I ever wanted to be as a result of honestly discharging my profession as a lawyer and the distinction of being Chief Minister."

When probed further with the question: "Did you say that you are wealthy because you are Chief Minister?"

The Chief Minister responded as follows:

"No, I said I am wealthy because of my work as a lawyer, no wealthier than you, probably less, and because of my salary as Chief Minister."

- 14. This report has already provided abundant evidence, as to how corrupt and rotten to the core are Pfizer. As a company, all across the world, they have a fearsome reputation for buying the loyalty of crooked politicians in exchange for their loyalty and support. Has Fabian Picardo benefitted financially from Pfizer's vaccine roll-out programme? It is not unfair to ask such a question. Former UK Prime Minister Rishi Sunak is known to have had huge financial interests in Moderna. Likewise, Fabian's discredited friend "Midazolam" Matt Hancock.ⁱⁱ, as he basked in the glory of Gibraltar's completion of phase one of the roll-out programme, a mere two months after the alarming number of deaths in the elderly care homes, had a very dubious connection with prescriptions issued for drugs like Midazolam.ⁱⁱⁱ Pride comes before a fall. If Pfizer vaccines were not a factor in the deaths in Gibraltar's saddest month, as we have been told, and that's an awfully big IF, given worldwide excess death patterns, were end-of-life drugs like Midazolam, likewise a factor in the sudden surge of deaths experienced in Gibraltar's saddest month, in the elderly care services?^{iv}
- 15. Within the last week, Fabian Picardo appeared before GBC's Ros Astengo to respond to the incident after the European Cup Final. During the victory celebrations in Madrid, players from Spain's winning men's Euro 2024 football team led crowds in chants of "Gibraltar is Spanish." Midfielder Rodri, who also plays for English club Manchester City, was among those chanting. The Gibraltar Football Association made an official complaint to UEFA, describing the chants as "extremely provocative and insulting". Fabian Picardo, expressed his anger over the chant, calling it "rancid". He also posted on social media, describing the singing as "disgusting". Bing's AI copilot says the following on the subject: "The situation highlights the ongoing tensions between Spain and Gibraltar, an enclave at Spain's southern tip that has been under British rule since the 18th century. The mixing of sporting victory with a chant that glorifies the dictatorial politics of Francisco Franco was particularly concerning to Picardo who described the former general as a murdering dictator."
- 16. Whilst I FULLY agree with and SUPPORT the Gibraltarian people in their being and REMAINING British, which they will always be under the coming reign and sovereignty of The Gibraltar Messenger/Christ, I find it somewhat hypocritical of CM Picardo referring to General Franco as a murdering dictator, considering his dictatorial stance over the unlawful and totally unnecessary lockdown, and his coercive administering of the murderous bioweapon mRNA injections, during the fake pandemic of the non-existent Covid-19 virus, akin to the old British saying: "It's the pot (**Picardo**) calling the kettle (**Franco**) black."
- 17. Immediately after Fabian Picardo was re-elected in October 2023, the chief minister had the Moorish Castle lit up in blue to signify solidarity with counterfeit Israel.^v

18. When Israel pulverised Gaza into rubble, killing thousands of children, atheist Picardo who had just paid homage to the Jesuit Pope Francis, tolerated a special silent interfaith prayer session for unity. No condemnation of counterfeit Israel's mass murdering genocide was allowed.^{vi}

- 19. Of course, it could be that Fabian Picardo has gained no financial benefits from Pfizer that have contributed to his wealth, or not, as the case may be, and that needs careful and thorough investigation. I guess the jury is still out on that one, hopefully not for much longer, but it can at least be confirmed that before becoming Chief Minister, Picardo did have a professional relationship with Israeli billionaire Dan Gertler. The GBC investigated and reported on this in 2018^{vii} Gertler become the subject of sanctions by the United States for allegedly amassing a fortune through corrupt mining deals. These sanctions were announced by former US President Donald Trump and then lifted just before Biden became President. Gertler, who reportedly has a net worth of over 1.2 billion dollars, is linked to companies based in Gibraltar that were involved in opaque and corrupt mining and oil deals in the Democratic Republic of Congo. - 20. As for Fabian Picardo's alleged £115million and his alleged <u>red ferrari</u>, I have no idea about that, but what I would be prepared to say is this: "That the only keys Fabian should hear jangling, are the prison officers' jangling keys locking him up at Windmill Prison for his acts of treason and crimes against humanity during the era of policing the corona state.

APPENDIX A

- The total number of cases of COVID-19 in Gibraltar today is 488
- However, of these, only three are in hospital.
- One case in the COVID ward is steadily improving.
- That person was vaccinated.
- One case is in the ICU has been ventilated, has improved and is no longer ventilated.
- That person was unvaccinated.
- Since we started testing we have carried out over 441-thousand PCR tests.
- We have carried out 1,427 such tests overnight.
- Of the 488 live cases in question, 397 are residents, 78 are non-residents and 13 are visitors.
- Of the 488 where we have variant data for;
- **149** are DELTA variant and 114 are OMICRON variant with the balance still being sequenced.
- Omicron is 70 times more infectious than Delta.Omicron appears to be more infectious but less threatening to life.
- But we must still ensure that we keep all strains of the virus under control in Gibraltar.
- For that reason, the Cabinet decided on Monday that we should once again convene the top echelon of the civil contingency command structure for the pandemic, COVID PLATINUM.
- COVID PLATINUM met this morning to assess the picture as we head into the Christmas holidays.
- The advice from the Director of Public Health, Dr Helen Carter, is clear:
- Although we already have community transmission, the curve of infections is flat.
- We are already reaping the benefits and rewards of having maintained a very precautionary approach this autumn.
- I know many of you will be watching UK and international news channels and you will be seeing nations around the world IMPOSING conditions and rules and cancelling events and celebrations.
- You may ask yourselves why your Government is not doing that here.
- The answer is that we, in Gibraltar, took those decisions and announced them some time ago.
- As far back as September and October we took the decision to cancel our large scale public events.
- We did that, NOT because we knew that we were going to face Omicron, which only arose later.
- We did it because we were not confident we could safely go ahead with those events.
- We therefore proceeded with caution to avoid expense and last minute cancellations.
- The same is true of mask wearing in shops and on public transport.
- So the reason you are not hearing us re-imposing those conditions today is simply because we never lifted the requirement in the first place.
- The reason we are not cancelling events today is because, this year, we simply did not organize them in the first place.
- We recognize that the prudence we have called for has affected some businesses this year too, although certainly not like last year when we shut down our catering industry.
- This year catering and hospitality may not be as busy as in other pre-pandemic years, but there is no shut-down as in last year.

As we did last year, however, we will work with the businesses that are having problems making ends meet these months to assist where possible.

- We will meet with the Federation of Small Businesses who have written asking us to consider how to help.
- And we will meet in the New Year with the Catering Association to properly calibrate how we can help in this new scenario in which businesses are open and operating but the take up is slower than in other years.
- But the reality is that the main reason we are seeing fewer hospitalisations in Gibraltar is plain and simply our very high vaccination rates.
- We have administered over 41,000 first doses and over 40,000 second doses of the Pfizer vaccine.
- To date we have already provided almost 27,000 third doses.
- We must continue to see the vaccines as the life-line that the United Kingdom has provided and that has enabled us to start to navigate our way back to normality.
- In fact, it is incredible to think it was just earlier this year that all our eyes were on the airport as we started to receive vaccines from the United Kingdom.
- We have never been closer to the United Kingdom or luckier to be part of the UK family of Nations.
- We have really reaped the reward of our British status this year and during this pandemic.
- As an aside, let me say that you should not let anything or anyone even suggest that any of us in Government would be prepared to gamble with that uniquely and exclusively British status in the ongoing UK/EU negotiations.
- As a result of the vaccination programme, I fully expect we will now be able to enjoy Christmas with our loved ones without the need for any further restrictions.
- Today I am therefore relieved to be able to tell you that I am announcing no further restrictions at all.
- There is today no requirement to restrict your civil liberties in order to protect life or the GHA's ability to protect life.
- Because we must neither fail to act nor overreact.
- We understand the impact that our decisions can have on other elements of life in Gibraltar.
- We understand the potential negative impacts of measures we might take to mitigate risks stemming from the pandemic.

- We understand that our decisions have an effect on our ability to get on with our lives.
- And to get on with the diagnosis and treatment of other life-threatening conditions.
- But to keep it that way in the face of the Omicron variant, we do need to see continued and full take-up of our booster vaccines.
- As of today, with those almost **27,000** having had a booster jab, we have approximately **70%** of those who had the initial two doses now boosted.
- Of the resident population 80% of over 50-year-olds who had the second dose have now been boosted.
- This is very good of course, but it is not excellent.
- It is not where we need to be.
- We have a way to go to ensure that everyone who had a second vaccine has a third booster.
- The GHA has pulled out all of the stops to get as many of you, who wanted to be, boosted before Christmas.
- I'm certain many of you will be taking your vaccine just as soon as you can.
- I am certain that we will continue to see a steady take-up in the New Year when the programme resumes.
- As we steer Gibraltar through what we hope, but cannot guarantee, will be a muted wave of hospitalisations, we are each making choices for ourselves that have consequences for ourselves and each of our fellow Gibraltarians.
- Because choices have consequences.
- Freedom of choice does not equal freedom from consequence.
- In the vaccine, and in the help we have had from the United Kingdom Government in 2021, we are fortunate enough to have the choice that can keep us safe.
- We have the one weapon that works better than anything against COVID.
- We have a way out of this pandemic which thousands of you have taken as part of the community-wide effort to get us out of this.
- I know many of you will have taken the vaccine DESPITE some reservations that you may have had.
- Despite those, you have balanced the needs of this community, your personal needs and the needs of your family and you have made the right choice.
- The consequence of this choice is that you join in with the community effort and we strengthen our hand against this threat when every one of us takes a moment to get boosted.
- Some have been advised by their doctors not to have the vaccine.
- There are many however, who have CHOSEN not to have the vaccine.
- There are many reasons why you may have CHOSEN not to take the vaccine some sensible, others less so.
- There are those who, in addition to refusing to take a vaccine, are also taking a stand against doing literally anything whatsoever that is recommended or suggested or, in some instances unfortunately, demanded or required for the protection of those around the unvaccinated.
- The choice is yours, of course.
- The consequence of that choice however, will also run to your account.
- Let me tell you that the two adults in hospital are of the same sex and of exactly, the same age.
- Both are men.
- They are in exactly the same age in their seventies.
- One is in the COVID ward and has only required some basic attention.
- He is vaccinated.
- The other patient, exactly the same age, and the same sex is in the ICU.
- He is not vaccinated by choice, not as a result of any medical advice.
- He has had to be intubated and ventilated, a highly invasive and dangerous procedure.
- Happily, he is today improving and we hope he will live to tell the tale of his battle with COVID.
- But it is very, very likely, that if he had been vaccinated he would not have required intubation and ventilation.
- That would have saved our health professionals a huge amount of stress, time and expense on his care.
- And so our booster vaccination programme has been successful, but I have to emphasise that we have not yet had the same uptake of boosters as we did on the first and second doses.
- It is important to understand that because our vaccination programme was so successful earlier this year the effect of the double vaccine is waning and it needs to be topped up with a third vaccine to boost our protection against the virus.
- It is very important that everyone has the COVID vaccine booster shot.
- Vaccines are humanity's shield against disease and infection.
- By having them, we act in community and we show we care for each other.
- By having them, we protect ourselves and we protect each other.
- I would ask that those who haven't yet had the booster should therefore please make arrangements to do so as soon as possible.
- The vaccine will keep you safe. More importantly it will also keep others safe.
- The higher the number of people in our community and our cross-frontier population who are vaccinated, the safer it makes it for all of us as a nation.
- Remember that, as with all vaccination programmes, taking a vaccine is an altruistic gesture. Our next vaccination clinic is on the 29th December and this is by appointment.
- The clinic after that will be dependent on the further numbers who have registered.
- Online registration is available at https://www.gha.gi/pfizerbooster/ and you will be called by the GHA with the details of your appointment.

We have to be mindful that the GHA and colleagues who are supporting them have been working flat out to keep you safe throughout this year.

The booster vaccination clinic has largely been undertaken after hours so as to minimize the impact on ordinary services.

We made the clinic available full time for a couple of weeks to be able to meet with the demand of the booster ahead of the Christmas break.

- We are conscious that our students will be returning to the UK soon as we of course want to ensure that they are boosted, so we have made special arrangements for them to ensure that they are given an appointment for their booster jabs as soon as possible.
- Any student who has not yet registered for the vaccination should do so via this link https://www.gha.gi/booster-registration-for-university-students/ which I will post on my Social Media feed.
- As a final point on vaccinations, if you have to decide what to do because you are unsure, don't just listen to me.
- Don't take legal advice from a scientist and don't take scientific advice from a lawyer.
- Ask your doctor.
- Don't ask Facebook, Google or YouTube.
- Please, do not take your advice from the internet or social media where the person giving you advice may not be qualified and may not even be the person that they say they are.
- More and more countries are introducing the need to have a Covid Digital Pass to gain access to venues including bars and restaurants.
- I can report that we launched our Covid Pass on the 8th November having worked on this with NHSx since the 1st July.
- It is totally EU compatible and works perfectly.
- However, we were removed from the EU Digital COVID Pass network by the UK when it became apparent that the EU had not been informed that Gibraltar was included with the United Kingdom's NHSx COVID Pass.
- As I have previously said, I have raised this with the Foreign Secretary and we are seeking to expedite administrative approval with the European Commission at the earliest opportunity.
- In the interim, the GHA's Covid Pass has been modified to enable users to download the PDF Certificate, if they wish to print them out, or request a Certificate on the official GHA/HMGOG letterhead which will be emailed to you.
- Given increased demand and the upcoming Christmas holiday break, this is expected to take at least 7 working days
- For all those of you who have now had the booster, I am pleased to tell you that these certificates are being updated to include the details of your booster by no later than 24 hours after you have had that vaccination.
- I will report to you further as soon as we have resolved the administrative issues with the European Commission.
- All of that of course is about convenience to travel and to access leisure.
- But, in the end, we must not forget that 2021 has been a year when we have lost 93 Gibraltarians to COVID.
- 7 more were lost in 2020.
- The COVID inquiry will begin as soon as possible in the New Year to enable us to learn the lessons of this pandemic and how to avoid such levels of causalities in the future.
- So as we head into the Christmas period, I ask you to spare a thought or a prayer for each of those we have already lost and for their friends and families as they face this season without their loved ones.
- I have written to the next of kin of all those who have succumbed to COVID.
- Today, I have also written to all public servants thanking them for their efforts this year and last.
- It has been as difficult for the public sector in 2021 as it was in 2020.
- I have extended my gratitude to all who have provided public services throughout.
- I have singled out those in health and care in particular, but all our public servants deserve recognition for the work done in this period.
- I also want to acknowledge, of course, that through our concentration on COVID and, in my case, also the Brexit negotiations, we will have failed to deal with some matters.
- I trust that as we get through 2022, we will be able to turn our attention again to many matters we have been unable to address during the pandemic.
- This is particularly true also of the GHA which has borne the brunt of the trauma of COVID and I am very pleased that Samantha Sacramento has shown the courage of leading a restart and recover programme in our health services.
- As a result, as we announced last month, from the 10th January the GHA will be run by a new Director General, answerable to a new GHA Board.
- All of this, in particular all employment matters and industrial relations for the health services, will be run by the Director General and not by any politicians.
- So as we turn our attention to the next few days, please remember the message every year from the RGP when they implore us not to Drink and Drive.
- Every year some people ignore this advice and so they put their own lives, and the lives of all other Gibraltarians at risk.
- This week, already 5 people have been arrested for Drink Driving offences and all of these drivers were way over the limit.
- This year, our free bus service is operating on every day of the holiday period and taxis are also available.
- Quite simply, there is NO excuse for anyone to drive home after they have had a few drinks.
- Nothing would give me greater pleasure than to be told, on the 4th of January, that there were no Drink Driving arrests over the holiday period.
- Alcohol also has a role to play in many of the cases of Domestic Abuse that are reported to the RGP and we cannot pretend that Domestic Abuse is not a problem not arising here in Gibraltar.
- To anyone who suffers in this way, I would say, 'Call the RGP they have experts who are available 24/7 to provide you with the support that you need.
- And if you see abuse taking place at a neighbour's house or with your relatives, I would implore you to let the RGP know about it.
 - Better to be safe than sorry.
- The RGP also continue to play a part in our efforts to minimise the spread of the latest Covid variants.

- In particular, they are working hard to ensure that everyone who arrives by air is tested immediately after their arrival and that people who have tested Positive are, indeed, self-isolating rather than spreading their infection amongst their friends and family.
- Only yesterday, **2** people were issued with **£300** Fixed Penalty Notices for being in breach of the Government's COVID-19 testing regulations.
- A local woman was also reported after she'd been seen irresponsibly socialising despite knowing full well that she had tested positive for COVID-19.
- We do not need such irresponsibility making it harder for the rest of us in the community.
- Please remember that, whether they are responding to Road Traffic incidents, cases of Domestic Abuse or of people breaking the Covid regulations, RGP officers are out there, keeping our community safe, 24 hours a day, 365 days a year.
- I thank them on behalf of all of us, as I do all our law enforcement, essential and emergency services for their continued service this festive season as the rest of us enjoy time away from our places of work.
- Christmas is also a stressful time for some.
- It can be overwhelming and I remind everyone that the GHA's mental health crisis line 111 is available 24 / 7 over the Christmas period.
- If you find yourself or a loved one in a mental health crisis, do not hesitate to call 111.
- Leading Gibraltar through these past 22 months has been the hardest thing I will ever do in public life.
- The past 22 months have been the hardest in the modern political history of Gibraltar and our people.
- For the whole Cabinet, the Deputy Chief Minister and for me, leading Gibraltar through these difficulties has never been a burden.
- It has always been a pride.
- Thank you for your fulsome continued support and confidence throughout this period.
- There are challenges to come, but none like this, with such great risk to so many of our precious people's lives.
- We look forward to a better year next year.
- To a more positive balance sheet in every respect.
- For now, before I take questions from the journalists assembled here, I want to wish all of my fellow Gibraltarians and residents of Gibraltar a Merry Christmas and a Happy New Year.
- If you are going away, as I hope to do for a few days, familiarise yourself with the rules in whatever destination you are headed for.
- Please enjoy the festivities with family and friends in a prudent and sensible way.
- Merry Christmas Gibraltar and a very happy and healthy start to the New Year.
