I, Tony Farrell, present this motion in relation to **both alleged criminal cases** currently before the Magistrates' Court of Gibraltar

I hereby give formal notice of my challenge to the sovereignty of Mr. Charles Battenberg / Mountbatten, also known by the criminal aliases Windsor and The Third, and thus the authority and jurisdiction of the court, and also the authority of the UK Parliament, the Gibraltar Parliament, the Governor of Gibraltar, the Gibraltar Judiciary, the RGP and the KCs to act on his behalf.

Charles the wife-murderer and adulterer is, like his mother Elizabeth before him, a fraud pretending to be and masquerading as the lawful monarch, when neither he nor his mother were ever lawfully crowned in the eyes and under the rule of God the Ruler of The Universe, and His Law that is the ONLY Law of this maximum-security Prison-Planet you call Earth. Condemned prisoners in this prison, meaning everyone on Earth, except Christ our Rightful King, who is here again now in His Second-Coming, have absolutely NO AUTHORITY whatsoever to make rules, regulations, laws, understandings, agreements, treaties, or anything else. This precludes membership of criminal organisations like, but not limited to the WHO, the UNO, the WEF and the NAZI EU.

Prisoners have to abide by the prison rules i.e. The Laws of God, and His eldest Son Christ our King. Christ is the Owner and Governor of this entire prison-planet and everyone and everything on it, including you. The judiciary that is having its jurisdiction challenged is obviously a party to the cause, and therefore the jurisdictional challenge can ONLY be adjudicated by an INDEPENDENT jury.

Therefore I demand that all proceedings and actions of any kind be stayed, and a date be set for my challenge to be heard before an impartial jury, before October the 12th.

All proceeding must, by Law be stayed, once the Sovereignty and Jurisdiction are challenged, until that challenge is resolved by adjudication of an impartial jury.

Please inform me when that has been arranged.
